ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Community Shopping District symbols and indications as shown on Map No. 10-I in the area bounded by:

A line 289.00 feet south of and parallel to West 43rd Street; South Western Avenue; a line 364.00 feet south of and parallel to West 43rd Street; and the public alley next west of and parallel to South Western Avenue;

To those of a C1-1 District.

Section 2. This ordinance shall be in force and effect from and after its passage and due publication.
