Western Ave.. Said sidewalk cafe area #1 shall be seventeen (17) feet in length and twelve point six (12.6) feet in width for a total of two hundred fourteen point two (214.2) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along N. Western Avenue. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Monday through Sunday 8:00 a.m. to 12:00 midnight
Compensation: \$600.00
SEATING CAPACITY: 25




