ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the DS-3 Downtown Service District symbols and indications as shown on Map No 11-K in an area bounded by:

South Green Street; West Jackson Boulevard; a line 117.13 feet west of and parallel to South Green Street; and a line 246.14 feet north of and parallel to West Jackson Boulevard

to those of a DX-5 Downtown Mixed-Use District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.



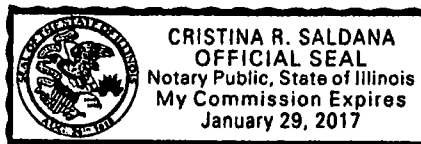

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 12, 2013, this firm will file an application for a change in zoning from a DS-3 Downtown Service District to a DX-5 Downtown Mixed-Use District on behalf of POGN LLC, for the property located at **832 West Jackson Boulevard**.
