*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to STARBUCKS COFFEE #2443 upon the terms and subject to the conditions of this ordinance to maintain and use two (2) Sign(s) projecting over the public right-of-way attached to its premises known as 1588 N MILWAUKEE AVE.

Said Sign structure(s) measures as follows along N. Milwaukee Avenue:

One (1) at sixteen (16) feet in length, one (1) feet in height and nine point six (9.6) feet above grade level.

Said Sign structure(s) measures as follows along :

One (1) at three point six (3.6) feet in length, one (1) feet in height and ten (10) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1558203 herein granted the sum of two hundred (\$200.00) per annum in advance.

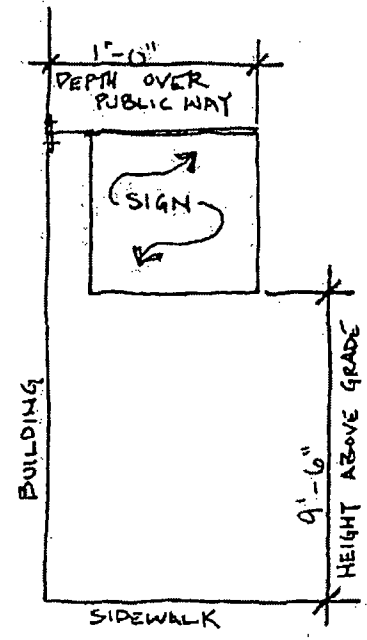
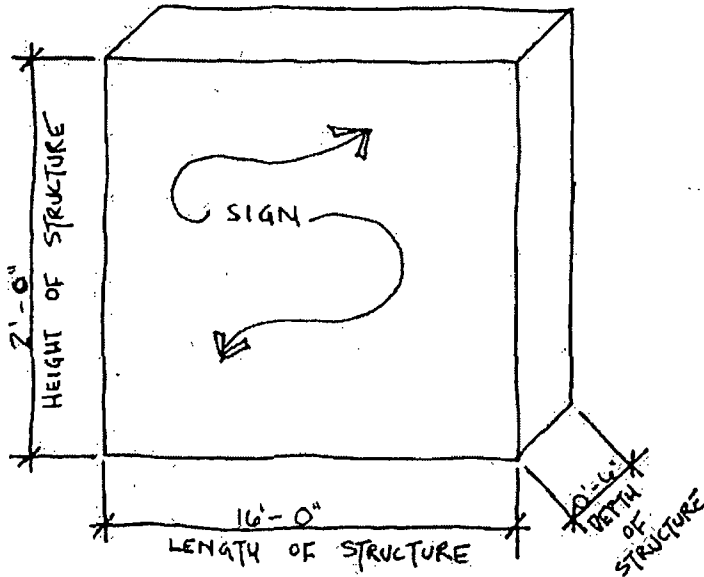
A 25% penalty will be added for payments received after due date.
