ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the B3-5 Community Shopping District symbols and indications as shown on Map No. 7-J in the area bounded by:

North Spaulding Avenue; the public alley next northeast of North Milwaukee Avenue;
North Sawyer Avenue; and North Milwaukee Avenue

to those of a C1-5 Neighborhood Commercial District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

Please take notice that under the Chicago Zoning Ordinance an application (the "Application") to change the B3-5 Community Shopping District to those of a C1-5 Neighborhood Commercial District for the area which is bounded by:


North Spaulding Avenue; the public alley next northeast of North Milwaukee Avenue; North Sawyer Avenue; and North Milwaukee Avenue

(hereafter the "Property") will be filed on or about March 10, 2015 with the Department of Planning and Development, City of Chicago by Cold One, Inc., 2725 N. Milwaukee Avenue, Chicago, IL 60647 (hereinafter the "Applicant"). The addresses of the Property are 2715 – 41 North Milwaukee Avenue, Chicago, Illinois 60630. The Owner of the Property is FY Development, LLC, 555 Skokie Blvd., Suite 500, Northbrook, IL 60062.

The Property is currently improved with two three-story buildings containing approximately 17,000 sq. ft. of retail/office space on the ground floor, seventy-eight dwelling units on the upper floors, twenty-two parking spaces and no loading berth.
