Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Greater Ravenswood Chamber of Commerce upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Sculpture(s) on the public right-of-way adjacent to its premises known as 4758 N RAVENSWOOD AVE.

Said Sculpture(s) at N Ravenswood Ave measure(s):

One (1) at four (4) feet in length and three (3) feet in width for a total of twelve (12) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.


This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP1536556 herein granted the sum of Zero (\$0.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

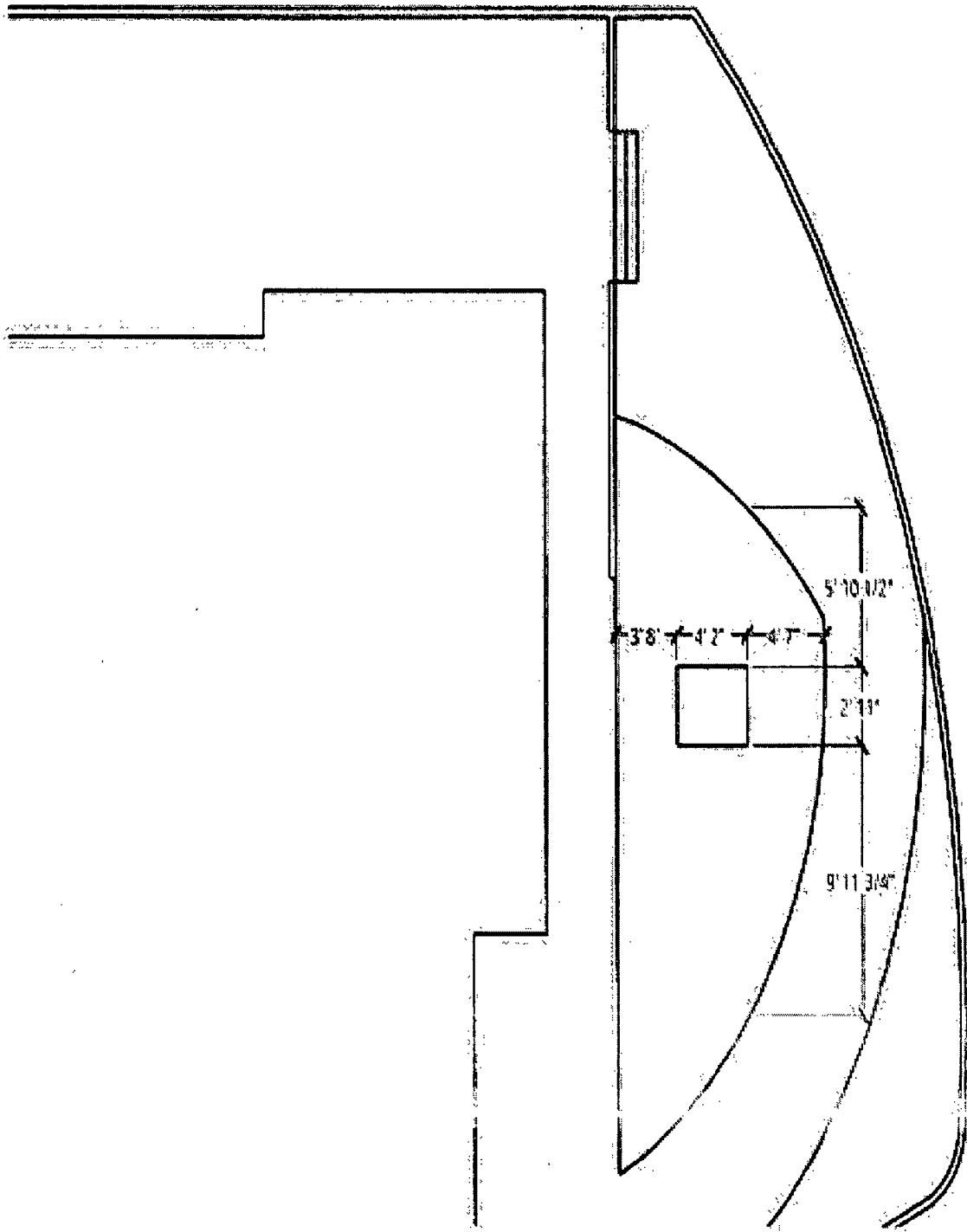
