ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RM-6.5 Multi-Unit Residential District symbols and indications as shown on Map Number 12-C in the area bounded by:

South Hyde Park Boulevard; a line beginning at a point on South Hyde Park Boulevard located 176.18 feet north of East 53rd Street as measured along South Hyde Park Boulevard and ending at a point located 175 feet west of South Hyde Park Boulevard and 121.15 feet north of East 53rd Street; a line parallel to and 175 feet west of South Hyde Park Boulevard; and a line beginning at a point located 175 feet west of Hyde Park Boulevard and 169.36 feet north of East 53rd Street and ending at a point on South Hyde Park Boulevard located 226.28 feet north of East 53rd Street as measured along South Hyde Park Boulevard

to those of the B3-5 Community Shopping District, which is hereby established in the area described above.

SECTION 2. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-5 Neighborhood Shopping District symbols and indications as shown on Map Number 12-C in the area bounded by:

South Cornell Avenue; a line beginning at a point located on South Cornell Avenue located 90.02 feet north of East 53rd Street as measured along South Cornell Avenue and terminating at a point 100 feet west of the westerly line of South Hyde Park Boulevard and 141.87 feet north of East 53rd Street; a line beginning at the last described point and terminating at a point 100 feet west of the westerly line of South Hyde Park Boulevard and 93.67 feet north of East 53rd Street; a line beginning at the last described point and terminating at a point 109.45 feet west of the westerly line of South Hyde Park Boulevard and 91.06 feet north of East 53rd Street; a line beginning at the last described point and terminating at a point on East 53rd Street located 172.17 feet east of South Cornell Avenue as measured along East 53rd Street; and East 53rd Street

to those of the B3-5 Community Shopping District, which is hereby established in the area described above.

SECTION 3. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B3-5 Community Shopping District symbols and indications as shown on Map Number 12-C in the area bounded by:

East 53rd Street; the easterly line of the Illinois Central Railroad; a line north of and approximately parallel to East 53rd Street beginning on the easterly line of the Illinois Central Railroad at a point located 150.35 feet north of East 53rd Street as measured along the easterly line of the Illinois Central Railroad and terminating at a point 55.17 feet west of South Cornell Avenue and 150.04 feet

north of East 53rd Street; a line beginning at the last described point and terminating at a point 64.21 feet west of the westerly line of South Cornell Avenue and 117 feet north of East 53rd Street; a line beginning at the last described point and terminating at a point located on South Cornell Avenue, 140.04 feet north of East 53rd Street as measured along South Cornell Avenue; Cornell Avenue; a line beginning at a point located on South Cornell Avenue located 90.02 feet north of East 53rd Street as measured along South Cornell Avenue and terminating at a point 175 feet west of the westerly line of South Hyde Park Boulevard and 121.15 feet north of East 53rd Street; a line beginning at the last described point and terminating at a point 175 feet west of the westerly line of South Hyde Park Boulevard and 169.36 feet north of East 53rd Street; a line beginning at the last described point and terminating at a point on South Hyde Park Boulevard located 226.28 feet north of East 53rd Street as measured along South Hyde Park Boulevard; South Hyde Park Boulevard; a line beginning at a point on South Hyde Park Boulevard located 176.18 feet north of East 53rd Street as measured along South Hyde Park Boulevard and terminating at a point located 100 feet west of South Hyde Park Boulevard and 141.87 feet north of East 53rd Street; a line beginning at the last described point and terminating at a point 100 feet west of the westerly line of South Hyde Park Boulevard and 93.67 feet north of East 53rd Street; a line beginning at the last described point and terminating at a point 109.45 feet west of the westerly line of South Hyde Park Boulevard and 91.06 feet north of East 53rd Street; and a line beginning at the last described point and terminating at a point on East 53rd Street 172.17 feet east of South Cornell Avenue as measured along East 53rd Street

to those of a Residential-Business Planned Development, which is hereby established in the area described above, subject to such use and bulk regulations as are set forth in the Plan of Development herewith attached hereto and made a part hereof and no others.

SECTION 4. This Ordinance shall be in force and effect from and after its passage and due publication.

Plan of Development Statements

1. The area delineated herein as Residential-Business Planned Development Number _____ (the "Planned Development") consists of approximately fifty-seven thousand nine hundred seventy (57,970) square feet (one and thirty-three hundredths (1.33) acres) net site area (the "Property"), which is depicted on the attached Planned Development Boundary and Property Line Map and on the attached Sub-Area Map. The Property is divided into three (3) subareas. Subarea A is owned by 1600 East 53rd Street, LLC, which is the "Applicant" under this Ordinance with respect to Subarea A. Subarea B is owned by 1644 East 53rd, LLC, which is the "Applicant" under this Ordinance with respect to Subarea B. Subarea C is owned by 5232 S. Hyde Park Boulevard, LLC, which is the "Applicant" under this Ordinance with respect to Subarea C. 1600 East 53rd Street, LLC, 1644 East 53rd, LLC, and 5232 S. Hyde Park Boulevard, LLC are collectively referred to in this Ordinance as the "Applicants".
2. All applicable official reviews, approvals or permits implementing this Planned Development shall be obtained by the Applicant or Applicants specified in Statement 3. Any dedication or vacation of streets, alleys, or easements, any adjustments of right-of-way, or any consolidation or re-subdivision of parcels, shall require a separate submission on behalf of such Applicants or their respective successors, assignees, or grantees and approval by the City Council.
3. The requirements, obligations and conditions contained within this Planned Development shall be binding upon each Applicant, its respective successors and assigns, grantees and lessees and, if different than an Applicant, the legal titleholders or any ground lessors of its Subarea. All rights granted hereunder to the Applicants shall inure to the benefit of the Applicants' respective successors and assigns and, if different than the Applicants, the legal titleholder or any ground lessors of their respective Subareas. Furthermore, pursuant to the requirements of Article 17-8-0400 of the Chicago Zoning Ordinance, at the time applications for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, the Property shall be under single ownership or under single designated control.

Single designated control for purposes of this Statement shall mean any application to the City for any amendment to this Planned Development or any other modification or change thereto (administrative, legislative or otherwise) shall be made or authorized by all the owners of the Property and any ground lessors, subject however to the following exceptions and conditions: (a) a written and recorded zoning rights agreement by and among the owners of the Property and binding the entirety of the Property may designate circumstances under which individual Applicants may seek amendments, modifications or changes to this Planned Development; (b) except to the extent prohibited by such a zoning rights agreement, each Applicant may unilaterally apply for amendments, modifications and changes to terms of this Planned Development applicable to its own Subarea, but no other

Applicant's Subarea; and (c) where portions of the improvements located on the Property have been submitted to the Illinois Condominium Property Act, the term "owner" shall be deemed to refer solely to the condominium association of the owners of such portions of the improvements and not to the individual unit owners therein.

Nothing herein shall prohibit or in any way restrict the alienation, sale or other transfer of all or any portion of the Property or any rights, interests or obligations therein. Upon any alienation, sale or any other transfer of all or any portion of the Property or the rights therein, other than an assignment or transfer of rights pursuant to a mortgage or otherwise as collateral for any indebtedness, and solely with respect to the portion of the Property so transferred, the term Applicant shall be deemed amended to apply to the transferee thereof (and its beneficiaries if such transferee is a land trust), and the seller or transferor thereof (and its beneficiaries if such seller or transferor is a land trust) shall thereafter be released from any and all obligations or liability hereunder with respect to the portion of the Property so transferred.

4. The following uses shall be permitted within Subarea A and Subarea B of the Planned Development: All permitted and special uses allowable in the B3-5 District, subject to the additional provisions of this paragraph. The following uses (which are otherwise permitted or special uses in the B3-5 District) shall be prohibited in the Planned Development: Body Art Services; Day Labor Employment Agency; Urban Farms; Currency Exchange; Payday/Title Secured Loan Store; Pawn Shop; Fortune Telling Service; Funeral and Internment Service; Gas Stations; Vehicle Sales and Service; Laundry/Dry Cleaning Plant; Free-standing Wireless Communication Facility; and Medical Cannabis Dispensing Organization. The following uses in the B3-5 District shall not require special use approval: Non-Accessory Parking in Subarea A of up to 45% or 78 spaces, whichever is less; School; Outdoor Patio located on a rooftop; Hotel; any Personal Service Uses; any Participant Sports and Recreation Uses; and any Financial Service Uses that are not otherwise prohibited by the provisions of this paragraph.

If Subarea C is developed in conjunction with Subarea B, pursuant to Statement 12, Subarea C shall have the same allowable uses as Subarea B. If Subarea C is developed independently of Subarea B, permitted uses within Subarea C (on all floors, including the ground floor) shall be as follows: Artist Live/Work Space; Detached House; Townhouse; Multi-unit residential; Schools (including playgrounds and enclosed storage of play equipment); Accessory and Non-Accessory Parking; and Bed and Breakfast.

In addition to the foregoing, any portion of the Property may be used on an interim basis during construction for construction staging, the storage of construction materials, and parking for construction purposes.

Use Map; Planned Development Boundary and Property Line; Sub-Area Map; Site Plan – Sub Area A; Site Plan – Sub Area B; Site Plan – Sub Area C; Green Roof Landscape Plan: Sub-Area A; Landscape Plan: Sub-Area A; South Elevation: Sub-Area A; East Elevation: Sub-Area A; North Elevation: Sub-Area A; West Elevation: Sub-Area A; Building Elevations: Sub-Area B; and Building Elevations: Sub-Area C. Full-size copies of the Site Plans, Landscape Plans and Building Elevations are on file with the Department of Planning and Development (the “Department”). These and no other zoning controls shall apply to the Property. The Planned Development conforms to the intent and purpose of the Chicago Zoning Ordinance, Title 17 of the Municipal Code of Chicago, and all requirements thereof, and satisfies the established criteria for approval as a planned development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control.

6. Signs existing in Subarea B on the effective date hereof shall be permitted within Subarea B, and all signs otherwise permitted in the B3-5 District shall be permitted within Subareas A and B, provided, however: (i) all other on-Premise signs shall be permitted within the Planned Development subject to the review and approval of the Commissioner of the Department (the “Commissioner”); (ii) temporary signs such as construction and marketing signs shall be permitted subject to the review and approval of the Department; and (iii) Off-Premise signs shall not be permitted in the Planned Development. Signs denoting the owner, developer or manager of the Subarea A improvements (including the name “Mac Properties”) shall be deemed On-Premise Signs.
7. The improvements on the Property shall be designed, constructed, and maintained: (i) in substantial conformance with this Planned Development and the applicable Approved Plans, subject to Statement 12; and (ii) in accordance with the parkway tree and the landscaping and screening provisions of the Chicago Zoning Ordinance.
8. Off-street parking and off-street loading facilities shall be provided in compliance with this Plan of Development. The required parking facilities within the Planned Development shall be permitted to have drive aisle and parking space dimensions in substantial conformity with those depicted on the Approved Plans.
9. Any service drive or any other means of ingress or egress, including for emergency vehicles, shall be adequately designed and paved in accordance with the provisions of the Municipal Code and the regulations of the Chicago Department of Transportation (“CDOT”) in effect at the time of review. There shall be no parking or storage of garbage receptacles within such service drives or within fire lanes. Any change to off-street parking ingress and egress as depicted in the Approved Plans shall be subject to the review and approval of CDOT and the Department.

All work in the public way must be designed and constructed in accordance with CDOT Construction Standards for Work in the Public Way and in compliance with the Municipal

Code of the City of Chicago. Closure of all or part of any public streets or alleys during demolition or construction shall be subject to the review and approval of CDOT.

The Applicants specified in Statement 3 shall obtain the applicable official reviews, approvals and permits from the various City Departments and or Committees regarding the use of the public way for any encroachments of public way space including encroachments on, over or under the street, sidewalk, parkway or alley. Such approval and permits shall require a separate submittal on behalf of such Applicants or their respective successors, assignees or grantees and approval by the City Council.

10. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. In addition to the maximum height of the building and any appurtenance thereto prescribed in this Planned Development, the height of any improvement shall also be subject to height limitations as approved by the Federal Aviation Administration.
11. For purposes of floor area ratio ("F.A.R.") calculations and floor area measurements, the definitions in the Chicago Zoning Ordinance shall apply, provided, however, no floor area used for parking and loading will count as floor area for F.A.R. purposes.
12. The terms, conditions and exhibits of this Planned Development ordinance may be modified administratively by the Commissioner upon the application for such a modification by the Applicants specified in Statement 3 and after a determination is made by the Commissioner that such a modification is minor, appropriate and consistent with the nature of the improvements contemplated in this Planned Development and the purposes underlying the provisions hereof. Any such modification of the requirements of this Planned Development by the Commissioner shall be deemed to be a minor change in the Planned Development as contemplated by Section 17-13-0611 of the Chicago Zoning Ordinance. It is acknowledged that interior parking layouts and demising walls for the rooms and other interior spaces as shown on the Approved Plans are illustrative only and that the reconfiguration of such interior spaces shall not be deemed to require any further approvals pursuant hereto.

It is also acknowledged that the building configurations and parking improvements shown on the attached Approved Plans for the development of Subareas B and C may be modified with a minor change approved by the Commissioner, either in connection with separate development of these Subareas or with a combined redevelopment of the two Subareas, so long as: (i) the height of all buildings within the applicable Subareas is less than 60 feet; (ii) the F.A.R. of the overall Planned Development does not exceed 5.0; (iii) the minimum lot area (MLA) for the overall Planned Development is in compliance with the MLA standards of the B3-5 Community Shopping District; (iv) the applicable Subareas provide no less parking than is required by the Zoning Ordinance for the buildings and uses to be approved by such minor change; and (v) the Department approves site plans, landscape plans and building elevations for the applicable Subareas (which site plans, landscape plans and building elevations shall thereafter be Approved Plans for the purposes of this Planned Development).

The existing building and other improvements within Subarea B are expressly permitted under this Planned Development, including any interior and exterior renovations that do not increase the existing building's floor area (16,000 square feet), and no minor change or Part II approval shall be required for such renovations.

13. The Applicants acknowledge that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. New buildings constructed within the Planned Development shall be in substantial compliance with the City of Chicago Sustainable Development Policy in effect on the date this Ordinance is approved (the "Policy"). For purposes of calculating Net Roof Area, relative to the area of green roofs provided for the Property (if any), Net Roof Area shall not include: perimeter setbacks; private decks; pool surface areas, rooftop structures and roof-mounted equipment, including structure and equipment house within any top-floor mechanical penthouse. The attached Green Roof Landscape Plan: Sub-Area A is provided for illustrative purposes only, and no Subarea within the Planned Development shall be required to provide any green roofs unless the applicable Applicant selects green roofs as a compliance tool under the Policy.
14. The Applicants acknowledge that it is in the public interest to design, construct and maintain buildings and other improvements within the Planned Development in a manner that promotes, enables, and maximizes universal access. Plans for all new buildings within the Planned Development shall be reviewed and approved by the Mayor's Office for People with Disability ("M.O.P.D.") to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote a high standard of accessibility.
15. Upon Part II Review for any improvements within the Property, a Part II Review Fee shall be assessed by the Department pursuant to Section 17-13-0610 of the Chicago Zoning Ordinance. The fee as determined by staff at the time is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any applicable Part II approval.
16. All further development within the Planned Development shall comply with the Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Fleet and Facility Management and Buildings under Section 13-32-125 of the Municipal Code of Chicago or any other provision of that Code.
17. Unless substantial construction of Subarea A has commenced within six (6) years following adoption of this amendment to the Planned Development, and unless completion is thereafter diligently pursued, the Zoning Administrator shall initiate a Zoning Map Amendment to rezone the Property to the pre-existing classifications of B3-5 Community Shopping District, B1-5 Neighborhood Shopping District, and RM6.5 Residential Multi-Unit District. Said six (6) years may be extended for up to one (1) additional year, if before expiration, the Commissioner determines that a good cause for such an extension is shown.









SITE PLAN - SUB AREA A




**GREEN ROOF LANDSCAPE

Dear Neighbor,

On or about January 18, 2017, I, the undersigned attorney, will file two applications on behalf of the applicants listed below: an application to the City of Chicago for a rezoning to create a Residential-Business Planned Development with underlying B3-5 Community Shopping District zoning and a corresponding application to the Chicago Plan Commission under the Lake Michigan and Chicago Lakefront Protection Ordinance (the “LPO”). Further details about the applicants, subject property, and proposed development are provided below.

PLEASE NOTE APPLICANTS ARE NOT SEEKING TO REZONE OR PURCHASE YOUR PROPERTY. Applicants are required to send this notice under applicable law (including Section 16-4-100(c) of the LPO and Section 17-13-0107 of the Chicago Zoning Ordinance) to persons listed in the records of Cook County as taxpayers or owners of a property within 250 feet, more or less, of the subject property.

Current Zoning Districts: Subarea A: B3-5 Community Shopping District; Subarea B: B1-5 Neighborhood Shopping District; Subarea C: RM 6.5 Residential Multi-Unit District.

Proposed Zoning District: Residential-Business Planned Development.

Nature, Scope and Purpose of Proposal:

Parking: Each Subarea will have at least the amount of on-site parking that is required under the Zoning Ordinance for any new buildings that are constructed. In addition, Subarea A also will provide one replacement parking space for each space in the Subarea’s current surface parking lot. Estimated parking minimums for each Subarea are 173 spaces for A, 16 spaces for B, and 6 spaces for C.

Dwelling Units: The overall Planned Development will have fewer dwelling units than allowable under current zoning or the B3-5 District. Estimated dwelling units for each Subarea are 250 for A, 0 for B, and 6 for C.

Commercial: A goal of the proposed development is to improve continuity of commercial improvements along the north side of 53rd Street between the Metra Station and lakefront, including creation of storefronts in Subarea A and replacement of the existing commercial building in Subarea B (but without displacing the existing business tenants). Subarea C will not have commercial uses unless it is developed jointly with Subarea B.

Floor Area Ratio and Building Height: The overall Planned Development will not exceed the B3-5 District’s allowable floor area ratio (5.0) and actually will have less allowable floor area than the current zoning allows for the three Subareas, if developed independently. The Planned Development also will place greater limitations on Subareas B and C, in terms of height (60 feet) and floor area ratio (less than 3.0), and focus redevelopment in Subarea A, which is adjacent to the Metra tracks and 53rd Street station. Maximum height for the Subarea A development will be 28 stories/295 feet (comparable to the existing height of the Cornell Village tower).

This letter provides a limited description of the proposed development, and the project will continue to evolve with input from City Departments, City officials and community members during the coming months. As applicants previously advertised in the Hyde Park Herald, Alderman Hairston hosted a community meeting in East Hyde Park on December 20, 2016 concerning the project, and an additional community meeting will be held in the neighborhood prior to any public hearings on the applications.
