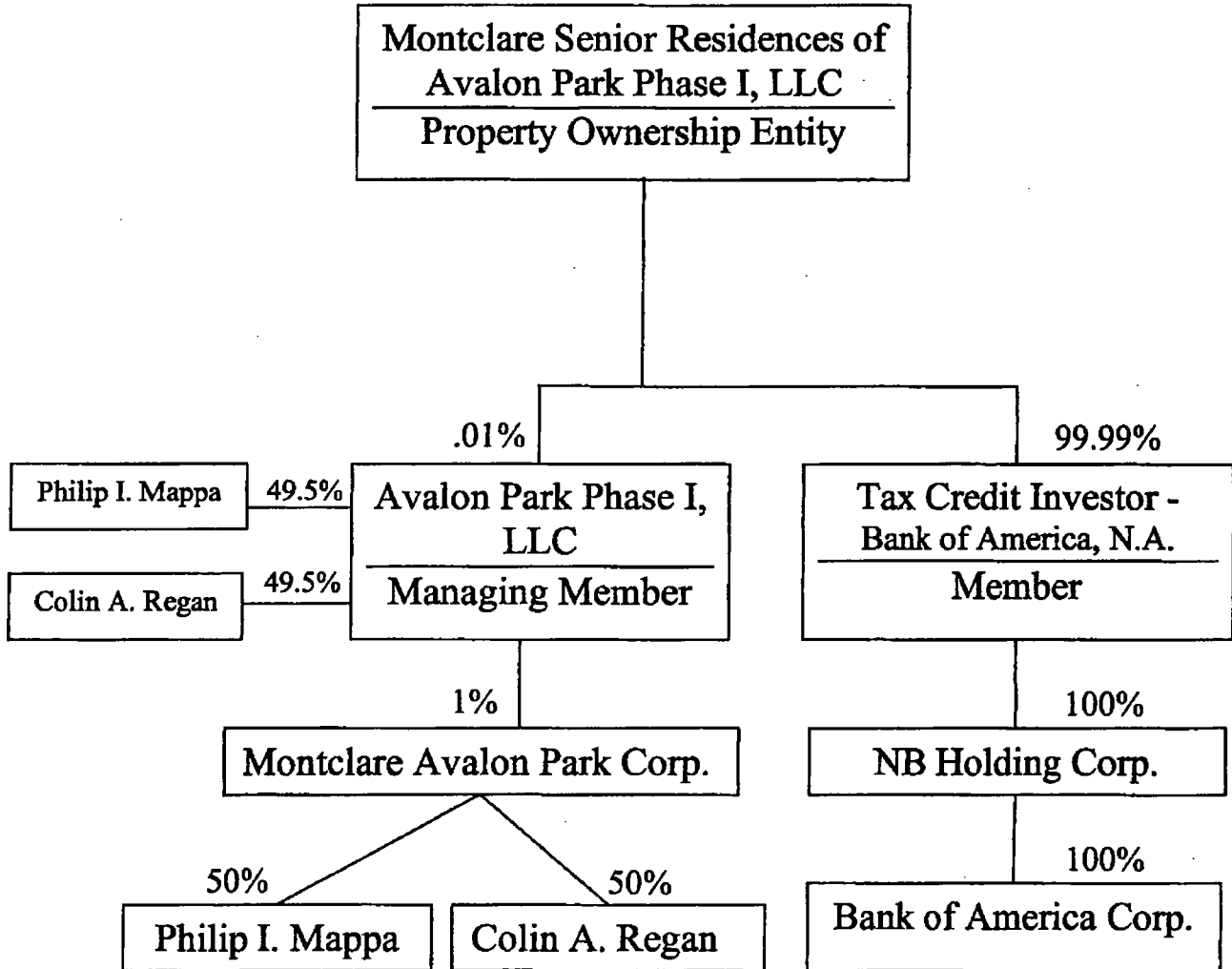

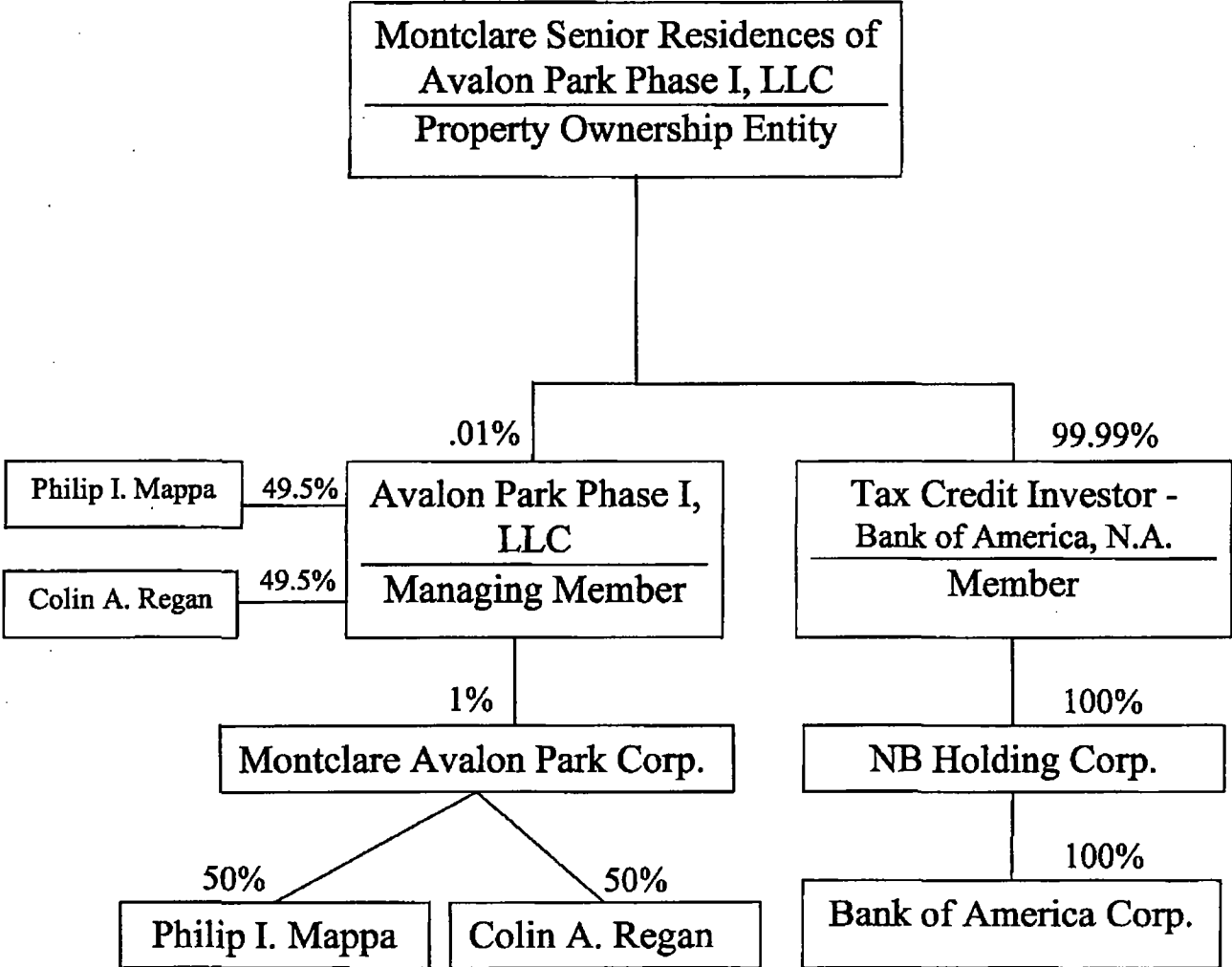

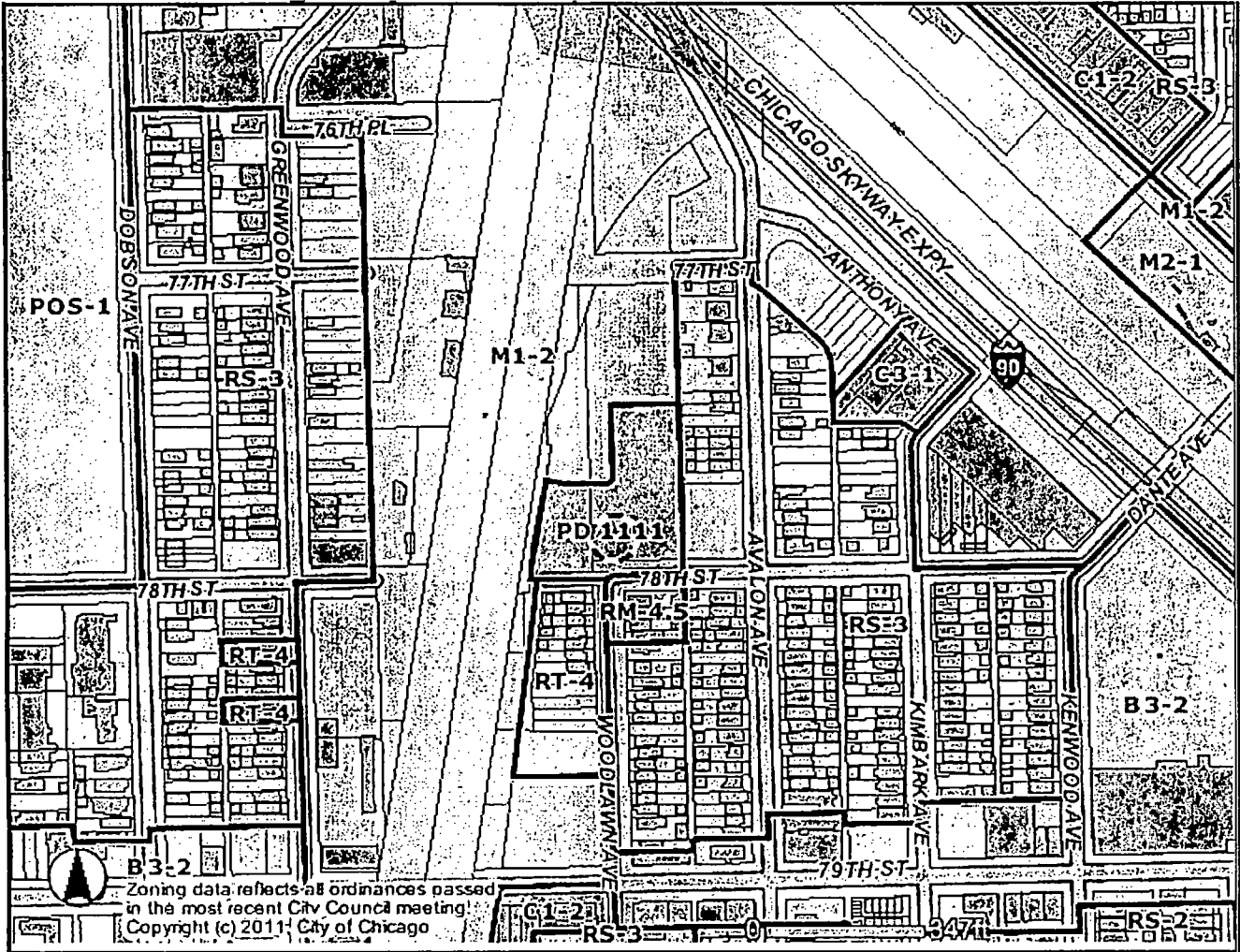
# Existing Zoning Map

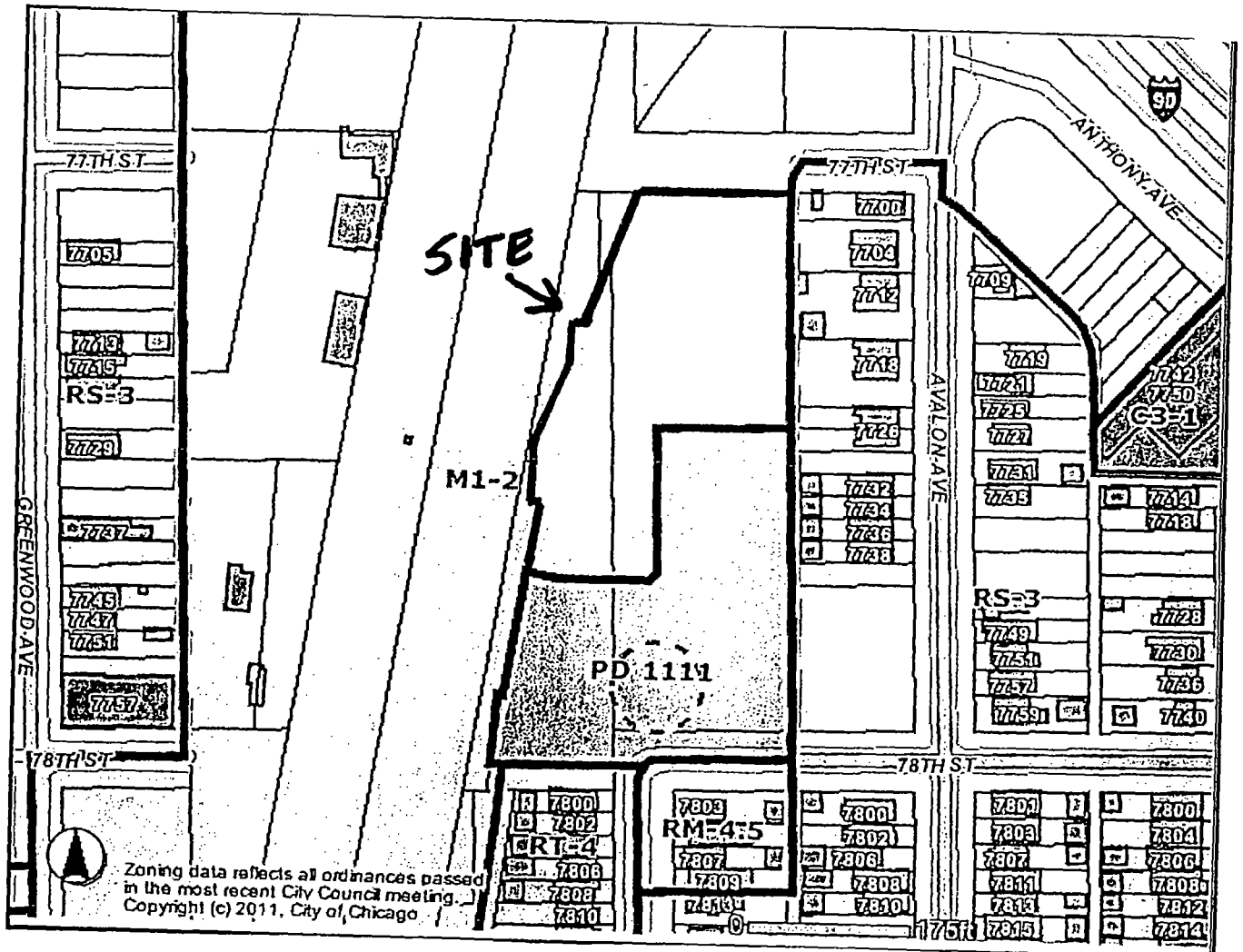


# Existing Land Use Map

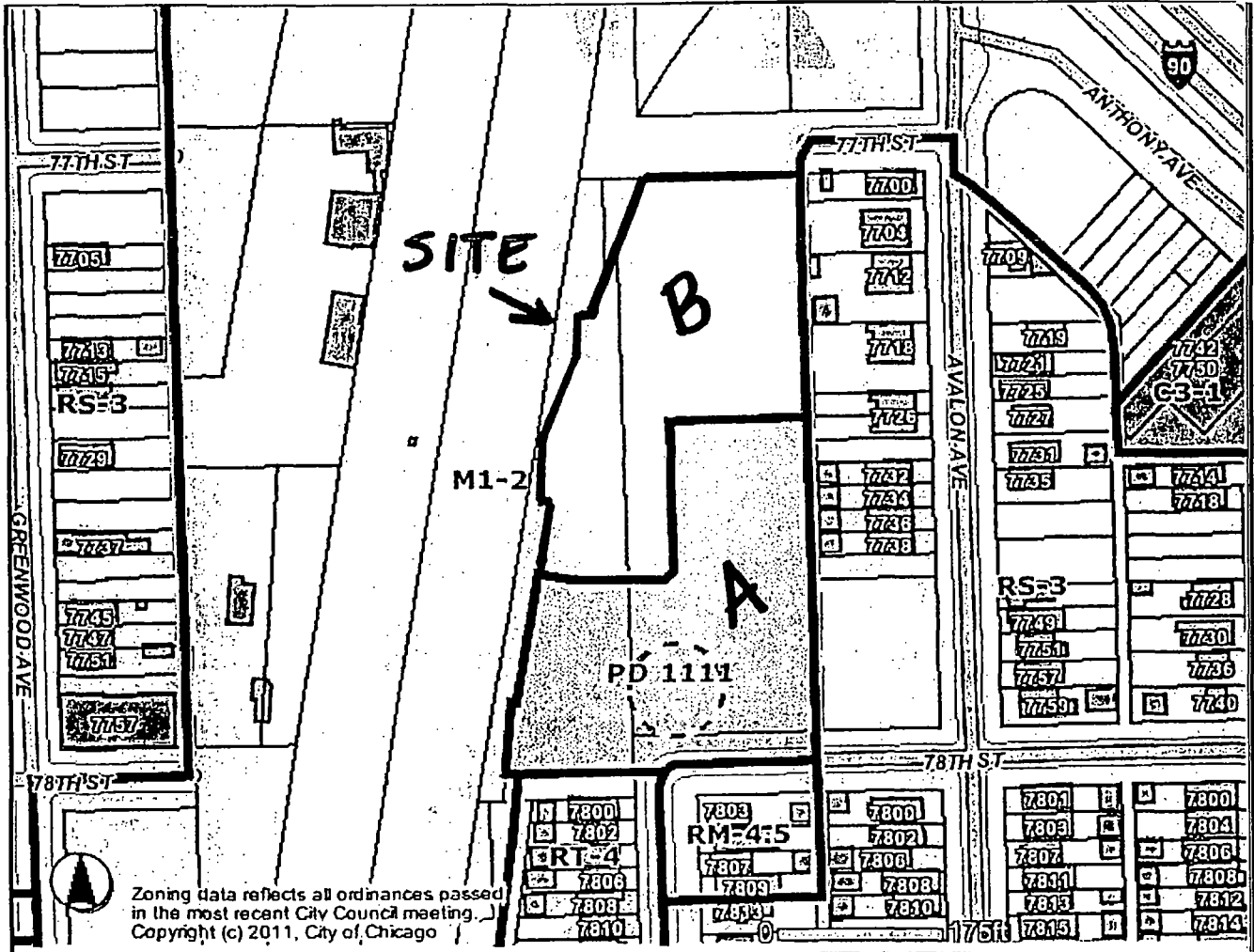

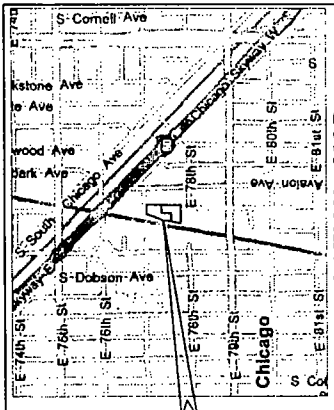
# Planned Development Boundary And Property Line Map
