Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to VILLAGE GREEN, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, nine (9) Planter(s) on the public right-of-way for beautification purposes adjacent to its premises known as 345 E. Ohio St .

Said Planter(s) at E. Ohio Street measure(s):

One (1) at twenty-five point one (25.1) feet in length, and six (6) feet in width for a total of one hundred fifty point six (150.6) square feet.

Said Planter(s) at E. Ohio Street measure(s):

One (1) at thirty-four (34) feet in length, and six (6) feet in width for a total of two hundred four (204) square feet.

Said Planter(s) at E. Ohio Street measure(s):

One (1) at thirty-seven (37) feet in length, and six (6) feet in width for a total of two hundred twenty-two (222) square feet.

Said Planter(s) at E. Ohio Street measure(s):

One (1) at twenty-one point nine (21.9) feet in length, and six (6) feet in width for a total of one hundred thirty-one point four (131.4) square feet.

Said Planter(s) at E. Grand Avenue measure(s):

One (1) at twenty-four (24) feet in length, and four point five (4.5) feet in width for a total of one hundred eight (108) square feet.

Said Planter(s) at E. Grand Avenue measure(s):

One (1) at twenty-five (25) feet in length, and four point five (4.5) feet in width for a total of one hundred twelve point five (112.5) square feet.

Said Planter(s) at E. Grand Avenue measure(s):

One (1) at twenty-five (25) feet in length, and four point five (4.5) feet in width for a total of one hundred twelve point five (112.5) square feet.

Said Planter(s) at E. Grand Avenue measure(s):

One (1) at six point six (6.6) feet in length, and four point five (4.5) feet in width for a total of twenty-nine point seven (29.7) square feet.

Said Planter(s) at E. Grand Avenue measure(s):

One (1) at eight point one (8.1) feet in length, and four point five (4.5) feet in width for a total of thirty-six point four five (36.45) square feet.

Grantee must allow the required clear and unobstructed space for pedestrian passage at all times per rules and regulations approved by the Department of Transportation.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required

provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1145614 herein granted the sum of zero (\$0.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

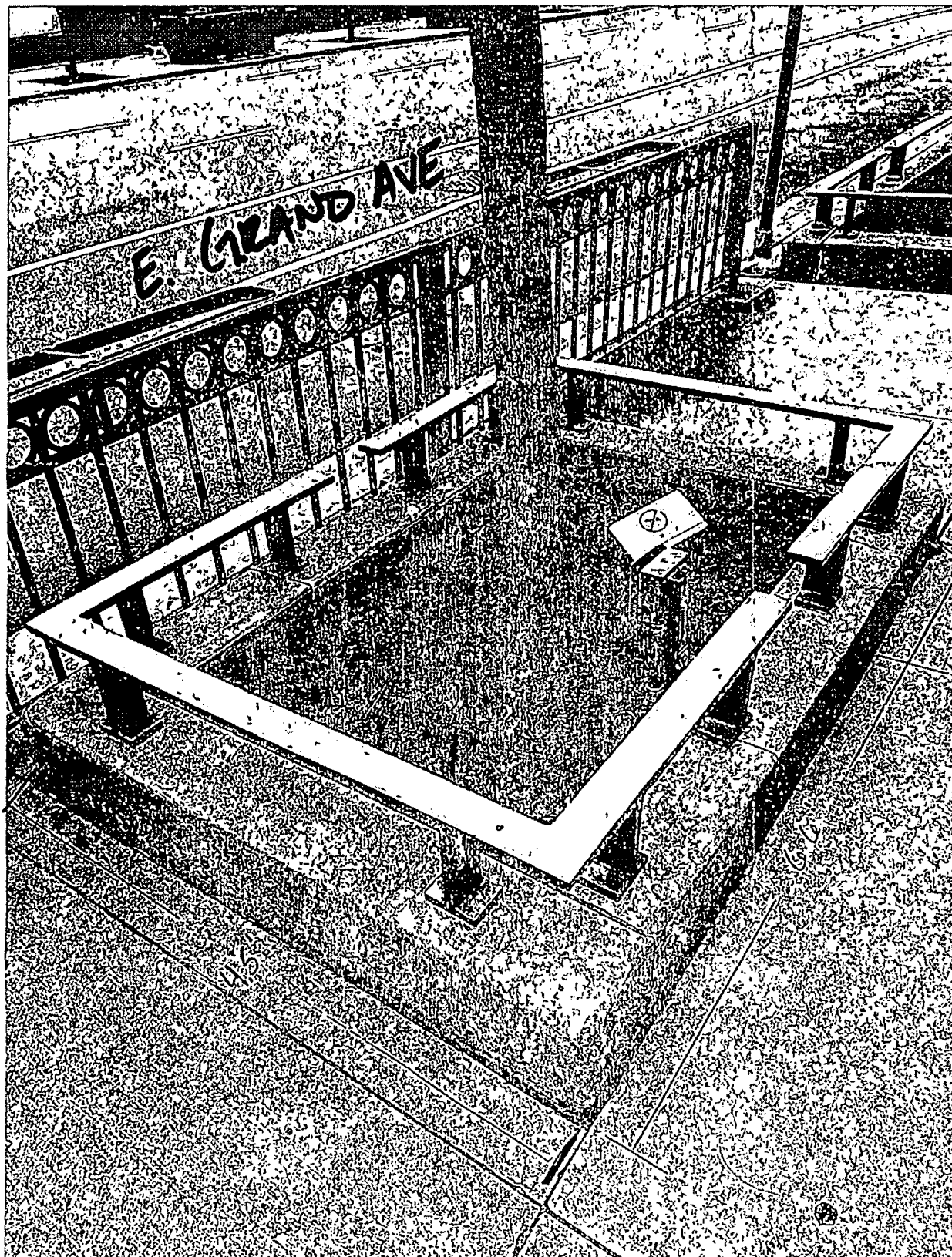
