TOW-AWAY ZONES:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64 of the Municipal Code of Chicago, the following locations are hereby designated as traffic lane tow-away zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

2	W. Adams Street (north side) from a point 25 feet west of S. Morgan Street to a point 25 feet west thereof, 30 Minute Standing Zone unattended vehicles must have lights flashing after 30 Minutes Tow Zone 10-00405290 - PO2010-1072;
2	S. California Avenue (east side) from a point 110 feet south of W. Lexington Street to a point 25 feet south thereof, 30 Minute Standing Zone unattended vehicles must have lights flashing 6:00 A.M. to 6:00 P.M., Monday through Friday, after 30 Minutes Tow Zone 10-01177059 - PO2010-4361;
2	S. Jefferson Street (east side) from a point 10 feet south of W. Grenshaw Street to a point 25 feet south thereof, 30 Minute Standing Zone unattended vehicles must have lights flashing 7:00 A.M. to 7:00 P.M., Monday through Saturday, after 30 Minutes Tow Zone 10-01178472 - PO2010-4400;
2	W. Grenshaw Street (south side) from a point 20 feet east of S. Jefferson Street to a point 25 feet east thereof, 30 Minute Standing Zone unattended vehicles must have lights flashing 7:00 A.M. to 7:00 P.M., Monday through Saturday, after 30 Minutes Tow Zone 10-01177119 - PO2010-4399;
2	W. Monroe Street (north side) from a point 20 feet west of S. Sangamon Street to a point 40 feet west thereof, 30 Minute Standing Zone unattended vehicles must have lights flashing 10:00 A.M. to 8:00 P.M., after 30 Minutes Tow Zone 10-01365101 - PO2010-4837;
2	S. Morgan Street (east side) from a point 20 feet north of W. Adams Street to a point 25 feet north thereof, 15 Minute Standing Zone unattended vehicles must have lights flashing 10:00 A.M. to 10:00 P.M., after 15 Minutes Tow Zone 10-01365129 - PO2010-4835;
2	E. Van Buren Street (south side) from a point 80 feet east of S. Wabash Avenue to a point 25 feet east thereof, 30 Minute Standing Zone unattended vehicles must have lights flashing after 30 Minutes Tow Zone 10-01365221 - PO2010-4834;
