227 MONROE STREET, INC

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 227 MONROE STREET, INC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use twenty-five (25) Light Fixture(s) projecting over the public right-of-way adjacent to its premises known as 227 W. Monroe St. .

Said Light Fixture(s) at W Monroe St measure(s):

Twenty-five (25) at thirty-two (32) feet in length, thirty-two (32) feet in width and thirty-two (32) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1116363 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

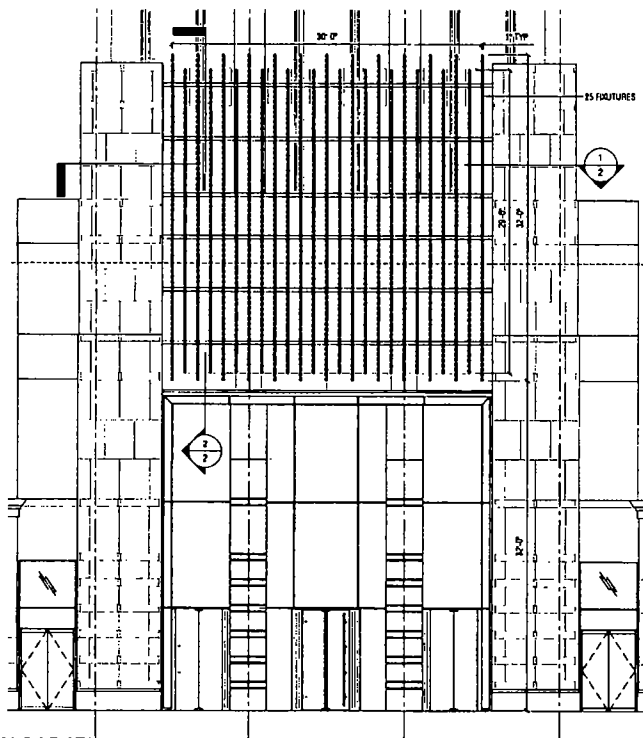

Authority herein given and granted for a period of five (5) years from and after Date of Passage.

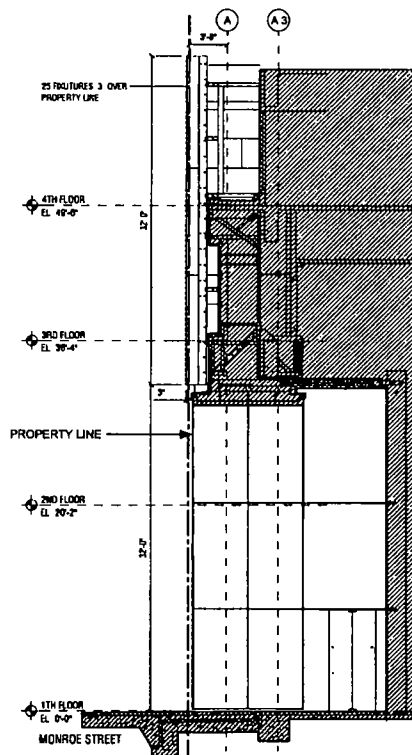

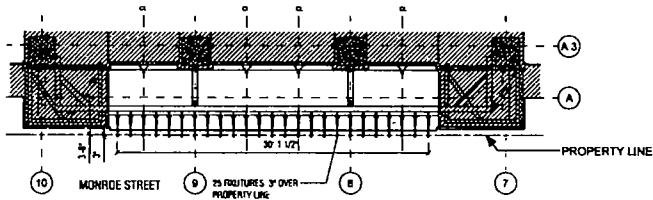
