*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to CRATE & BARREL, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, Building Projection(s) projecting over the public right-of-way adjacent to its premises known as 850-54 W. North Ave.. Existing projection extend over the sidewalk at the second (2<sup>nd</sup>) and third (3<sup>rd</sup>) floors of the building at the following dimensions. Area projection along West North Avenue is one hundred twenty-three and eight-tenths (123.8) feet in length extending three (3) feet beyond the property line. Second (2<sup>nd</sup>) floor projection is a minimum of twenty-six (26) feet above grade and is sixteen (16) feet seven, four (4) inches in length, extending to seven (7) feet, four (4) inches and having a depth of twelve (12) feet, three (3) inches at the building corner.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).


This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

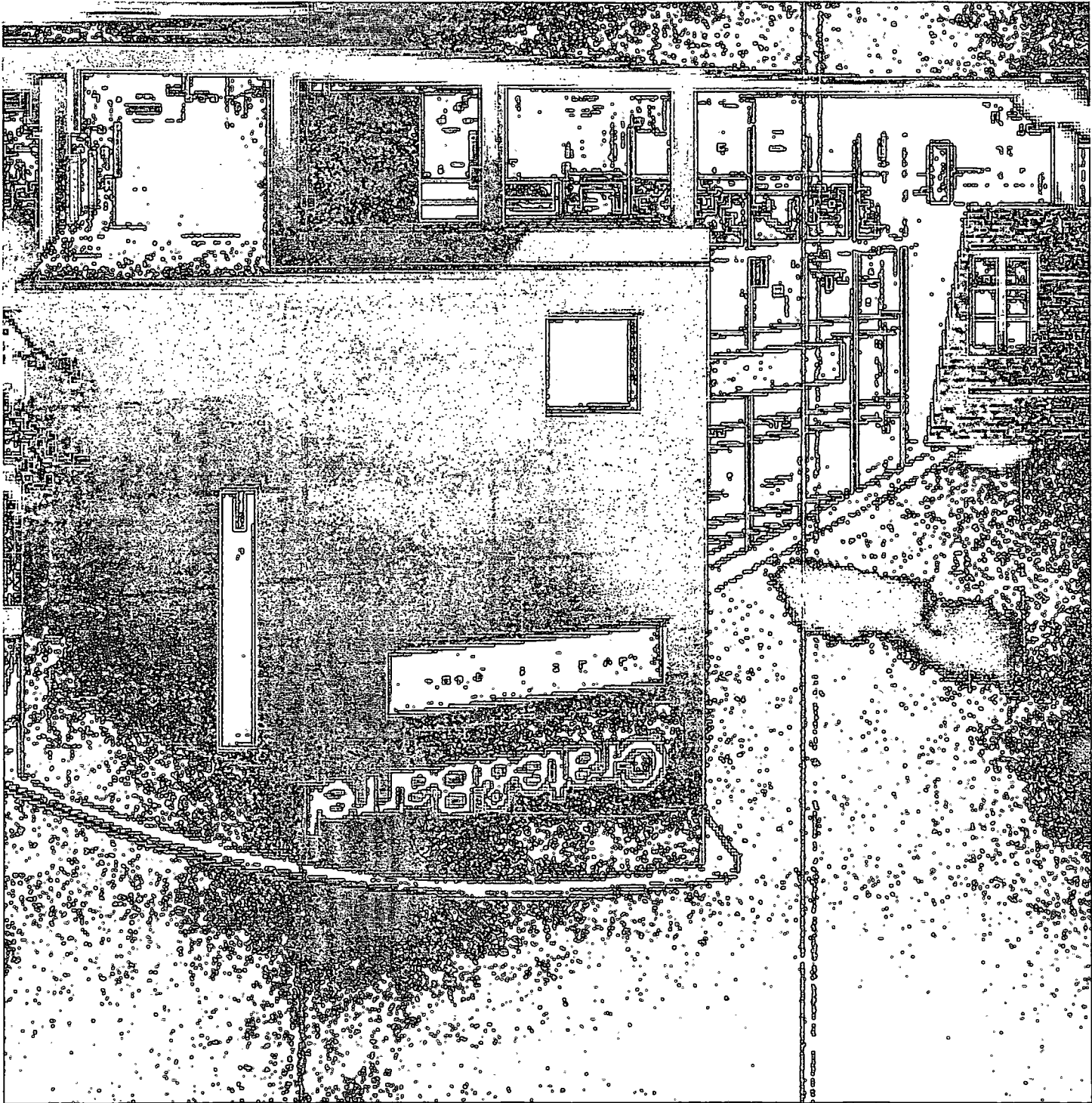
The grantee shall pay to the City of Chicago as compensation for the privilege #1100485 herein granted the sum of two thousand ninety (\$2,090.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 04/16/2012.
