ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2, Community Shopping District and M1-2, Limited Manufacturing/Business Park District symbols as shown on Map 5-H in the area generally bounded by:

a line 214.09 feet northwest of West North Avenue and perpendicular to North Milwaukee Avenue as measured along the southwest line of North Milwaukee Avenue; North Milwaukee Avenue; West North Avenue for a distance of 165.65 feet to the CTA right-of-way; the CTA right-of-way; the alley next southwest of North Milwaukee Avenue

to the designation of a Business Planned Development, subject to the use and bulk regulations set forth in the Plan of Development attached hereto and made a part hereof.

SECTION 2. This ordinance takes effect after its passage and approval.

In compliance with the notice requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about October 16, 2013, an application for an Amendment to the Chicago Zoning Ordinance will be filed on behalf of 1616-1624 N. Milwaukee Ventures, LLC, the Applicant, for the property commonly known as 1600-1626 North Milwaukee Avenue.

The Applicant proposes to renovate and re-use the historic 12-story Northwest Tower building and the historic 5-story Hollander building. A new 2-story building will be constructed adjacent to the Hollander building. The buildings will be utilized as a single development and the proposed uses include lodging, retail and restaurants. Plan of Development Statements

1. The area delineated herein as Planned Development No. _____ (“Planned Development”) consists of approximately 16,787.26 square feet (0.38 acres) of property which is depicted on the attached Planned Development Boundary and Property Line Map (“Property”) and is under the single designated control of the Applicant, 1616-1624 N. Milwaukee Ventures, LLC.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant’s successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for an amendment, modification or change (administrative, legislative or otherwise) to this Planned Development is made, shall be under single ownership or single designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.
3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. The City of Chicago acknowledges that the adaptive re-use and modernization of the existing historic buildings, which represents approximately 90% of the total floor area of the Property, is a significant sustainable contribution to the built environment. 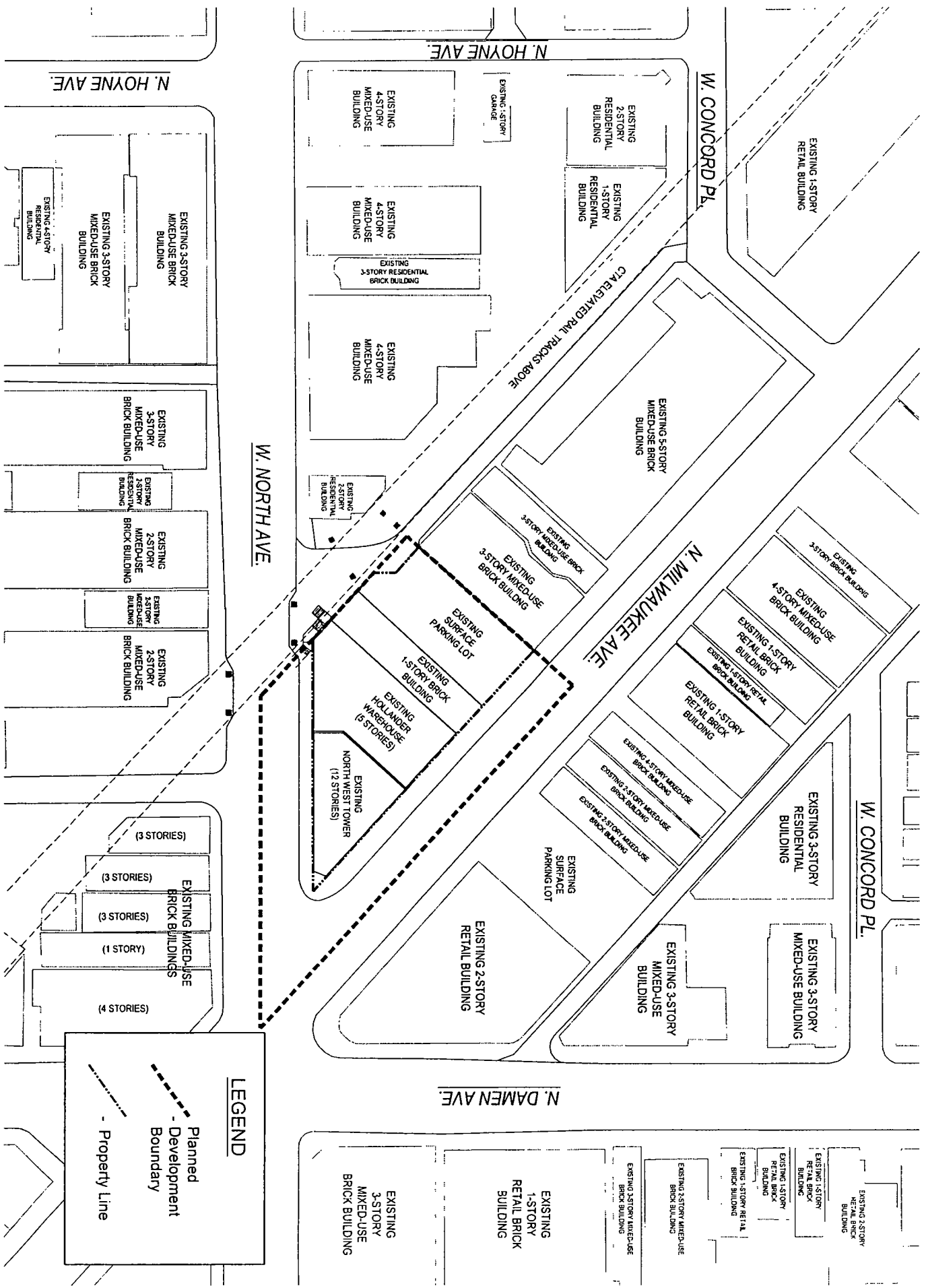




Existing Zoning Map

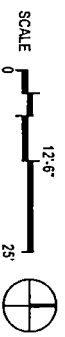
Site / Ground Floor Plan

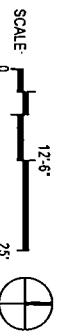
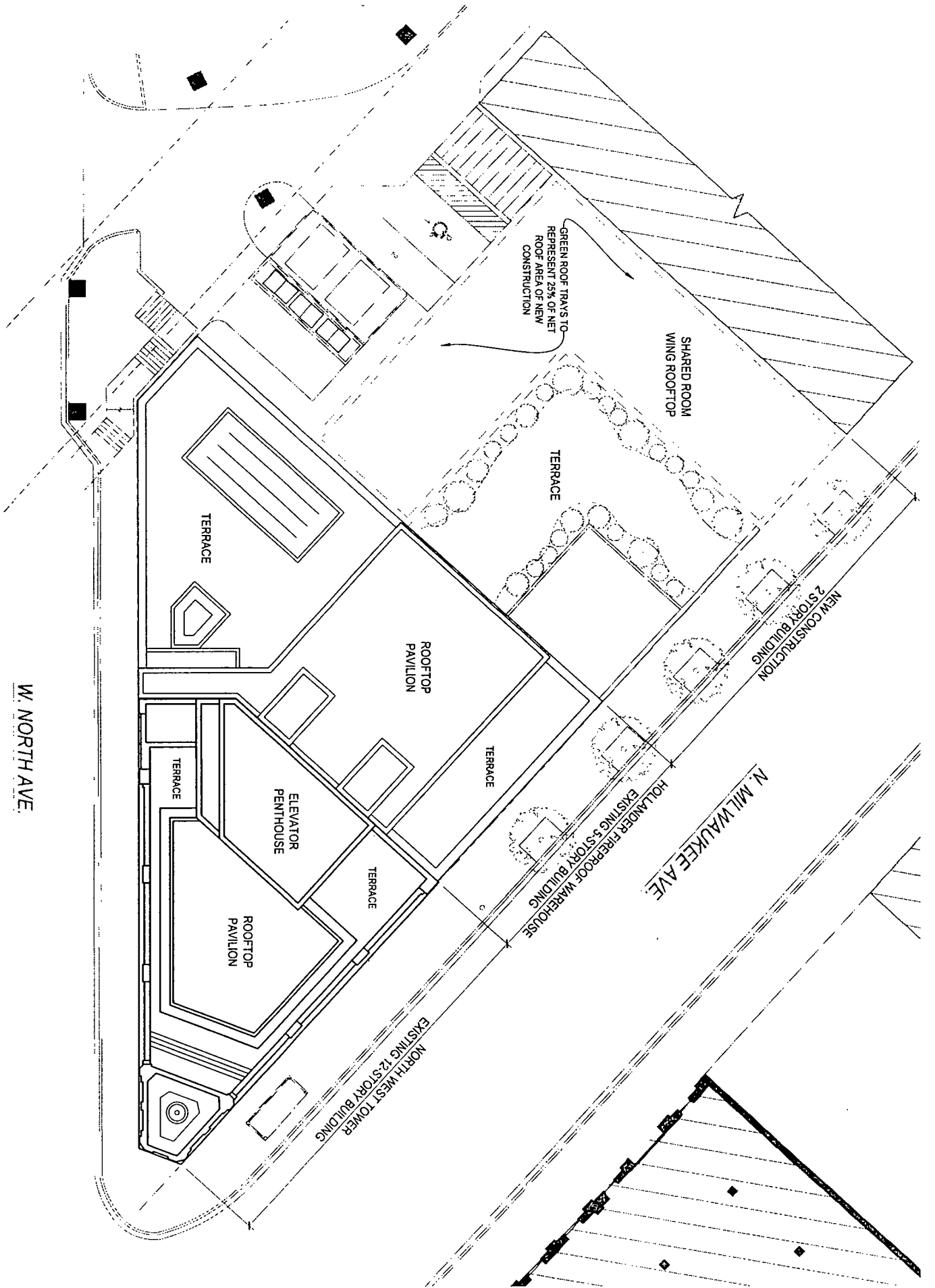

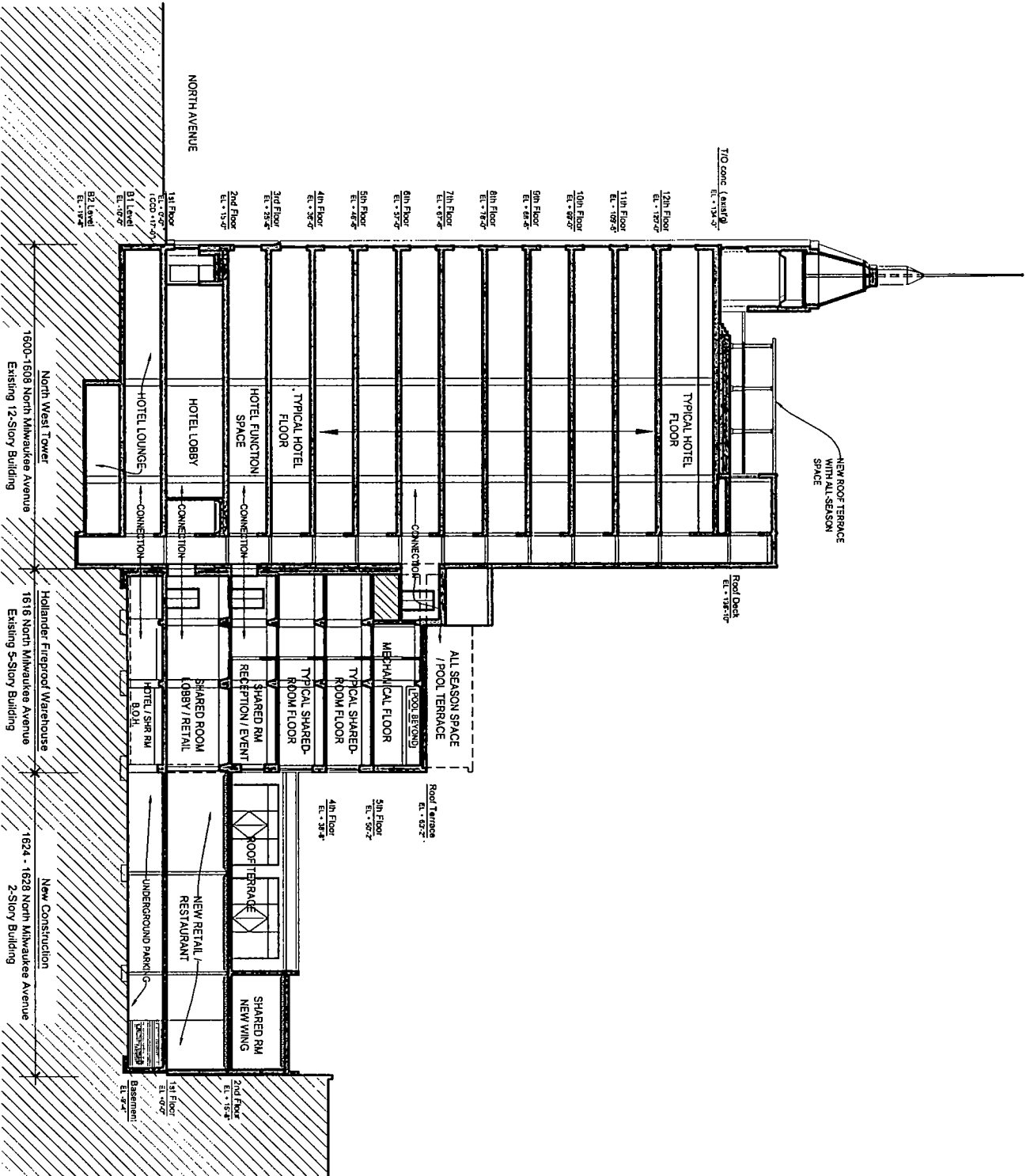


ROOF PLAN

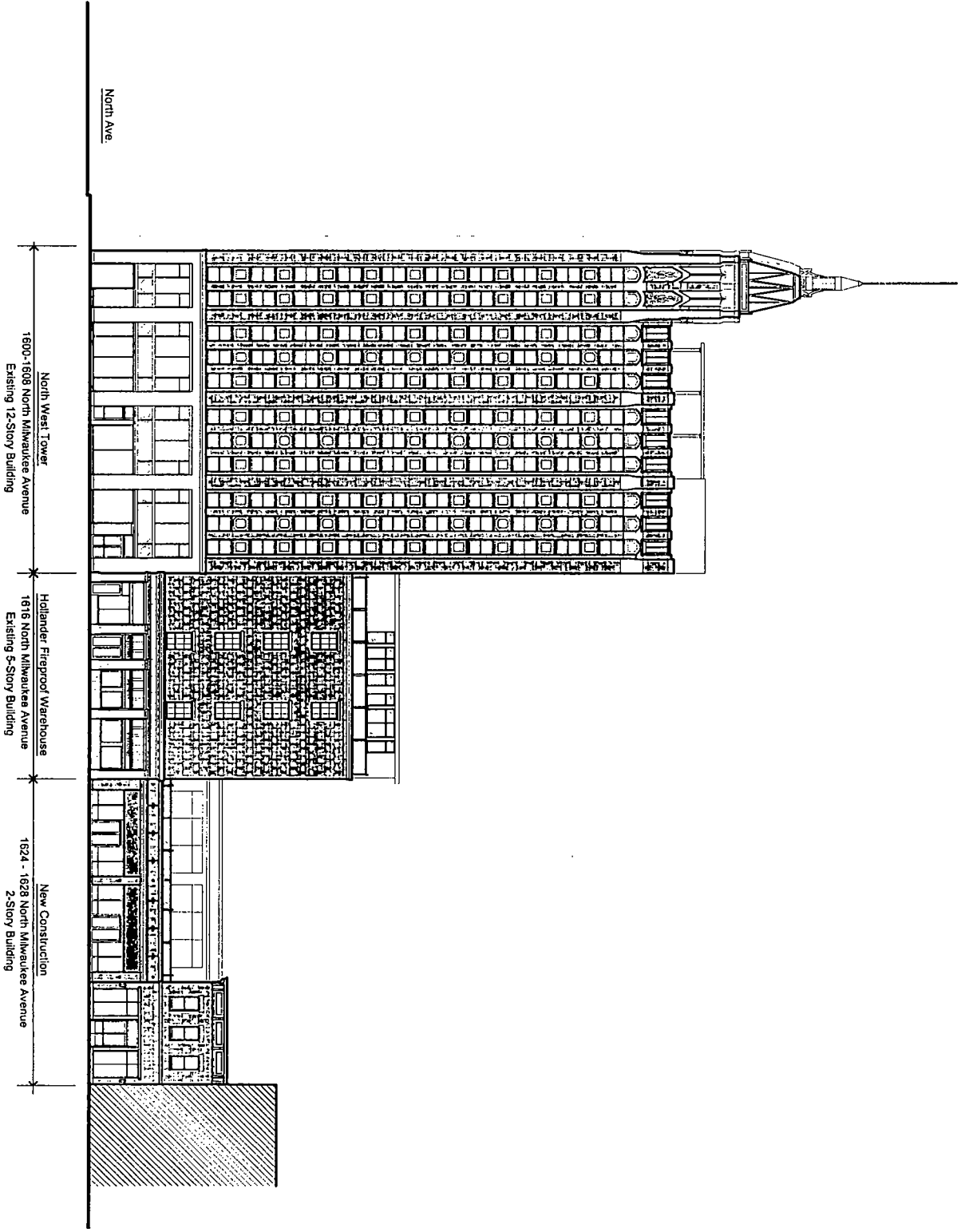

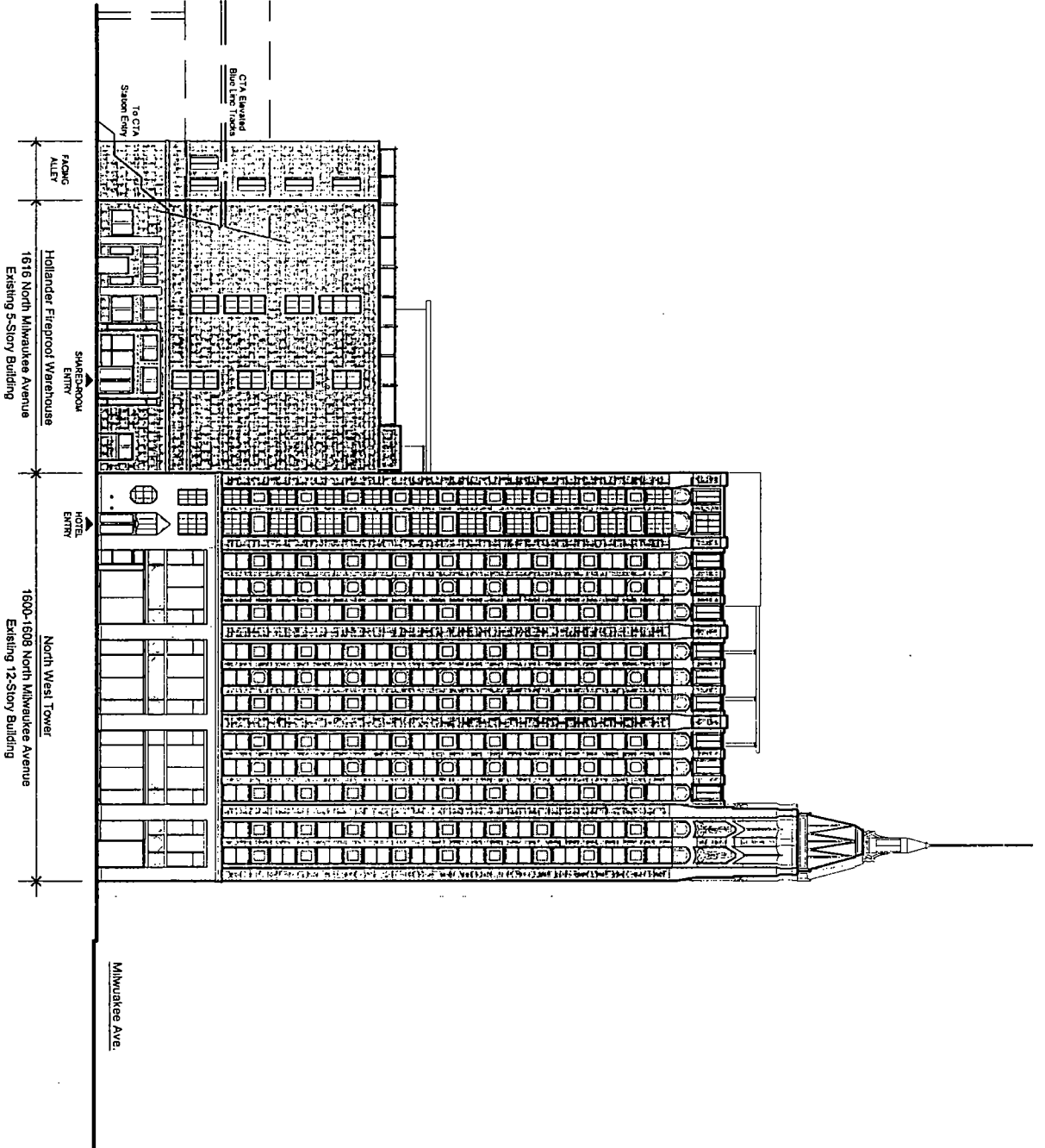
MILWAUKEE AVE. BUILDING ELEVATION

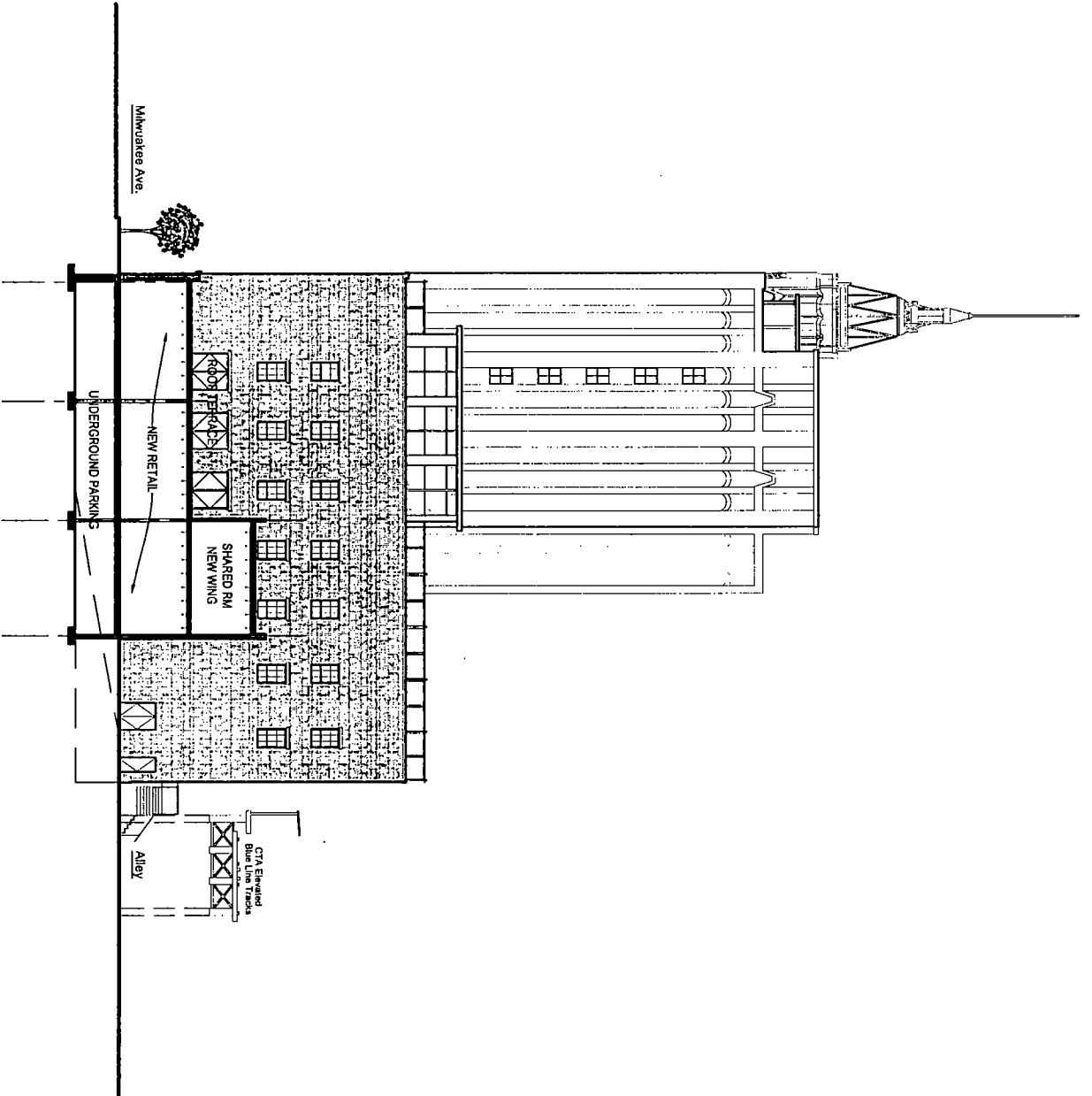
