Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to silver leaf wine & spirits, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Light Fixture(s) projecting over the public right-of-way adjacent to its premises known as 3402 W. Fullerton Ave..

Said Light Fixture(s) at W. Fullerton Avenue measure(s):

Four (4) at one point zero eight (1.08) foot in length, two point two five (2.25) feet in width and eleven (11) feet above grade level

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1130917 herein granted the sum of ninety (\$90 00) per annum in advance.

A 25% penalty will be added for payments received after due date

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

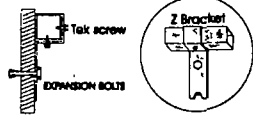

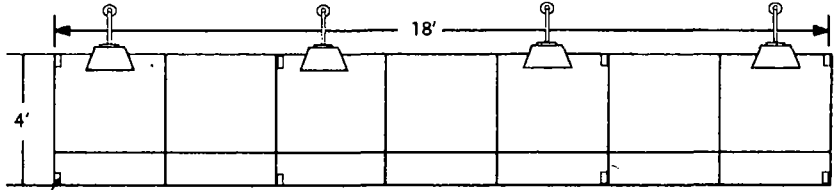
AWNING / LIGHT FIXTURE

FRAME WALL MOUNTING BRACKET

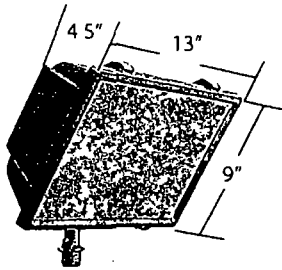


1X1 SQUARE GALVANIZED TUBE

Awning frames can easily be mounted with these brackets.
Made from 3/16 in hot rolled steel.
Two holes spaced equally for lagging into mortar are provided to secure bracket to wall. There is also a 3/16 in. Lag screw. Done a Tak screw for fastening the frame will accommodate a 3/8 in. Lag screw.
