ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to an ordinance approved by the City Council of the City on October 1, 2003 and published in the Journal of Proceedings of the City Council for such date at pages 8618 through 8620 (the "2003 Ordinance"), the City Council has previously approved the City's conveyance of that certain real property commonly known as 7601-7635 South Racine, Chicago, Illinois, and more particularly described in Exhibit A attached hereto and made a part hereof (the "Property") to TGH Restaurant Group of Chicago, Inc., a Georgia Corporation (the "Purchaser"); and

WHEREAS, pursuant to the 2003 Ordinance, the City and Purchaser entered into that certain Agreement for the Sale and Redevelopment of Land, recorded in the Office of the Cook County Recorder of Deeds on December 15, 2004 as document # 0435033169 (the "Agreement"). The Agreement provided that Purchaser would purchase the Property from the City for \$143,000, renovate the existing restaurant and construct an addition which would house a training center and offices; and

WHEREAS, the Purchaser renovated the restaurant and operated it for several years, although it is currently closed, but did not construct the addition; and

WHEREAS, Edgebrook Bank, located at 6000 W. Touhy Avenue, Chicago, Illinois (the "Bank") holds a mortgage on the Property, which mortgage is in default; and

WHEREAS, the Purchaser has authorized the Bank to find a buyer for that portion of the Property that the restaurant sits on, more particularly described in Exhibit B attached hereto and made a part hereof (the "Restaurant Property"), and to convey the Property to such a buyer; and

WHEREAS, the Bank has a contract to sell the Restaurant Property; and

WHEREAS, in order to facilitate the sale of the Restaurant Property, the Bank has requested that the City release the Agreement as to the Restaurant Property and grant it permission to sell the Restaurant Property; and

WHEREAS, the new owner will reopen the restaurant, providing services and jobs and eliminating a vacant, underutilized building in the community; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO;

SECTION 1. The foregoing recitals are hereby adopted as the findings of the City Council.

SECTION 2. The Mayor or his proxy is authorized to execute, and the City Clerk is authorized to attest, such recordable instrument as may be necessary or appropriate to release the Agreement and grant permission to sell the Restaurant Property. The Commissioner of the Department of Housing and Economic Development shall also have authority to execute and deliver such recordable instruments and such other documents as may be reasonably necessary to implement the terms of this ordinance.

SECTION 3. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 4. All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 5. This ordinance shall be in full force and effect immediately upon its passage and approval.

C. If the City determines that any information provided in this EDS is false, incomplete or inaccurate, any contract or other agreement in connection with which it is submitted may be rescinded or be void or voidable, and the City may pursue any remedies under the contract or agreement (if not rescinded or void), at law, or in equity, including terminating the Disclosing Party's participation in the Matter and/or declining to allow the Disclosing Party to participate in other transactions with the City. Remedies at law for a false statement of material fact may include incarceration and an award to the City of treble damages.

D. It is the City's policy to make this document available to the public on its Internet site and/or upon request. Some or all of the information provided on this EDS and any attachments to this EDS may be made available to the public on the Internet, in response to a Freedom of Information Act request, or otherwise.
