ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications shown on Map No. 6-F in the area bounded by

West 26th Street; a line 50.00 feet East of and parallel to South Normal Avenue; the alley next South of and parallel to West 26th Street; and South Normal Avenue.

to those of a C-1 Neighborhood Commercial District.

Section 2. This ordinance shall be in force and effect from and after its passage and due publication.
