**WHEREAS,** The hard work, sacrifice and dedication of Thomas H. Boggs, Jr., serve as an example to all; and

**WHEREAS,** His love of life and ability to live it to the fullest endeared Thomas H. Boggs, Jr., to his family members, friends and all who knew him, and enabled him to enrich their lives in ways they will never forget; and

**WHEREAS,** Thomas H. Boggs, Jr., was an individual of great integrity and accomplishment who will be dearly missed and fondly remembered by his many relatives, friends and admirers; and
