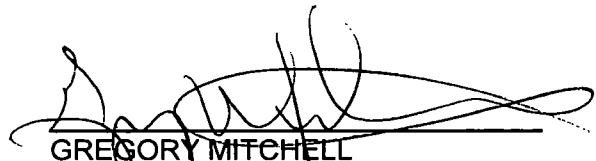
(SENIOR CITIZEN SEWER REFUND)
