SECTION 1. Pursuant to Section 10-20-430 of the Municipal Code of Chicago, the Commissioner of Transportation is hereby authorized and directed to exempt **The Bahr Co**. from the provisions requiring barriers as a prerequisite to prohibit alley ingress and egress to parking facilities for **4908 North Elston Avenue**.
