SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 18-E in the area bounded by

East 79th Street; a line 49.92 feet west of and parallel to South St. Lawrence Avenue; the public alley next south of and parallel to East 79th Street; a line 107.28 feet west of and parallel to South St. Lawrence Avenue,

to those of a C1-2 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about January 21, 2014, I, the undersigned, will file an application for a change in zoning from a B3-2 Community Shopping District to a C1-2 Neighborhood Commercial District on behalf of Drop-In-Lounge, LLC, applicant for a tavern liquor license at 551 E. 79th Street. The property encompasses 551-553 E. 79th Street, the existing phone store at 551 E. 79th St. and restaurant at 553 E. 79th Street will remain with no changes.






