- WHEREAS, Rose Kelly received a Bachelor of Arts degree in History from the University of Illinois at Urbana-Champaign in 1976; a J.D. from John Marshall Law School in 1981 and an M.B.A. from the Anderson School of Management at the University of California at Los Angeles; and
- WHEREAS, From 1977 to 1981, Rose Kelly was employed with the Mayor's Office of Employment and Training as Supervisor of Program Review and Audit. Her diligent work, ensuring that subcontractors complied with federal regulations and guidelines, resulted in significant benefits to the City's balance sheet; and

Her hard work and skills were recognized with a promotion to Senior Counsel in 2003, and she has served with vigor and distinction in that position ever since; and
- **WHEREAS**, In her years as a member of the Legal Counsel Division, Rose Kelly has become an indispensable and trusted counselor to elected officials, appointed officers and employees Citywide; and
- WHEREAS, Rose is admired and valued as a "go-to" person for her crisp, no-nonsense advice, cogent analysis, hard work and wide-ranging institutional knowledge on subjects ranging from finance to firearms; and
