A line 261 feet South of and parallel to West 59<sup>th</sup> Street; the alley next East of and parallel to South California Avenue; a line 291 feet South of and parallel to West 59<sup>th</sup> Street; and South California Avenue.

to those of a RT4 Residential Two-Flat, Townhouse and Multi- Unit District.
