
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

RESIDENTIAL TENANTS you have the right to either:

(A) pay the amount due and deduct it from your rent

OR

You may qualify for legal assistance in connection with this notice. Please see "Legal Assistance" in the white or yellow pages of your telephone directory.

It is unlawful for the landlord or agent to alter, deface, tamper with or remove this notice under the penalty of a Class C Misdemeanor.
