ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RT4 Residential Two-Flat, Townhouse and Multi-Unit District, POS-1 Regional or Community Park District and M2-2 Light Industry District symbols and indications as shown on Map No.12-H in the area bounded by

beginning at a line 649.85 feet north of and parallel to West Garfield Boulevard; a line 596.79 feet east of and parallel to South Western Boulevard; a line 483.81 feet north of and parallel to West Garfield Boulevard; a line 439.9 feet east of and parallel to South Western Boulevard; a line 428.24 feet north of and parallel to West Garfield Boulevard; a line 296.6 feet east of and parallel to South Western Boulevard; a line 483.81 feet north of and parallel to West Garfield Boulevard; a line 266.60 feet east of and parallel to South Western Boulevard; a line 448.10 feet north of and parallel to West Garfield Boulevard; South Western Boulevard; a line 574.64 feet north of and parallel to West Garfield Boulevard; a line 306.28 feet east of and parallel to South Western Boulevard; a line 616.94 feet north of and parallel to West Garfield Boulevard; a line from a point 616.94 feet north of Western Garfield Boulevard and 340.37 feet east of South Western Boulevard; to a point, 610.62 feet north of West Garfield Boulevard and 403.92 feet east of South Western Boulevard; a line 403.92 feet east of and parallel to South Western Boulevard; a line 601.82 feet north of and parallel to West Garfield Boulevard; and a line 466.76 feet east of and parallel to South Western Boulevard (ToB),



Aside from demolition of the west end of the building, no new construction is proposed or intended for the exterior of the building. All proposed construction will occur inside the existing building. There are no dwelling units proposed for the property.


















VICINITY MAP

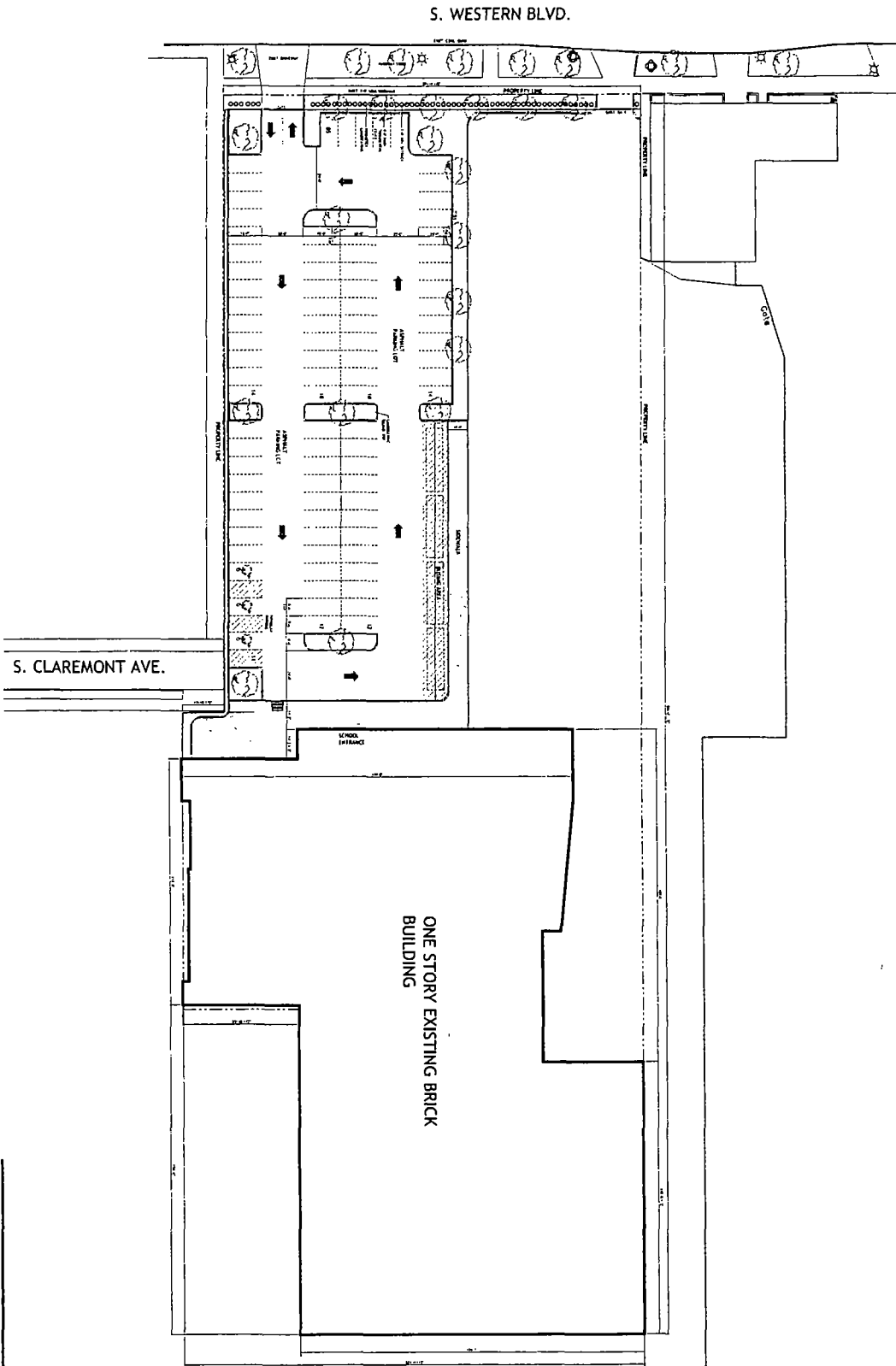

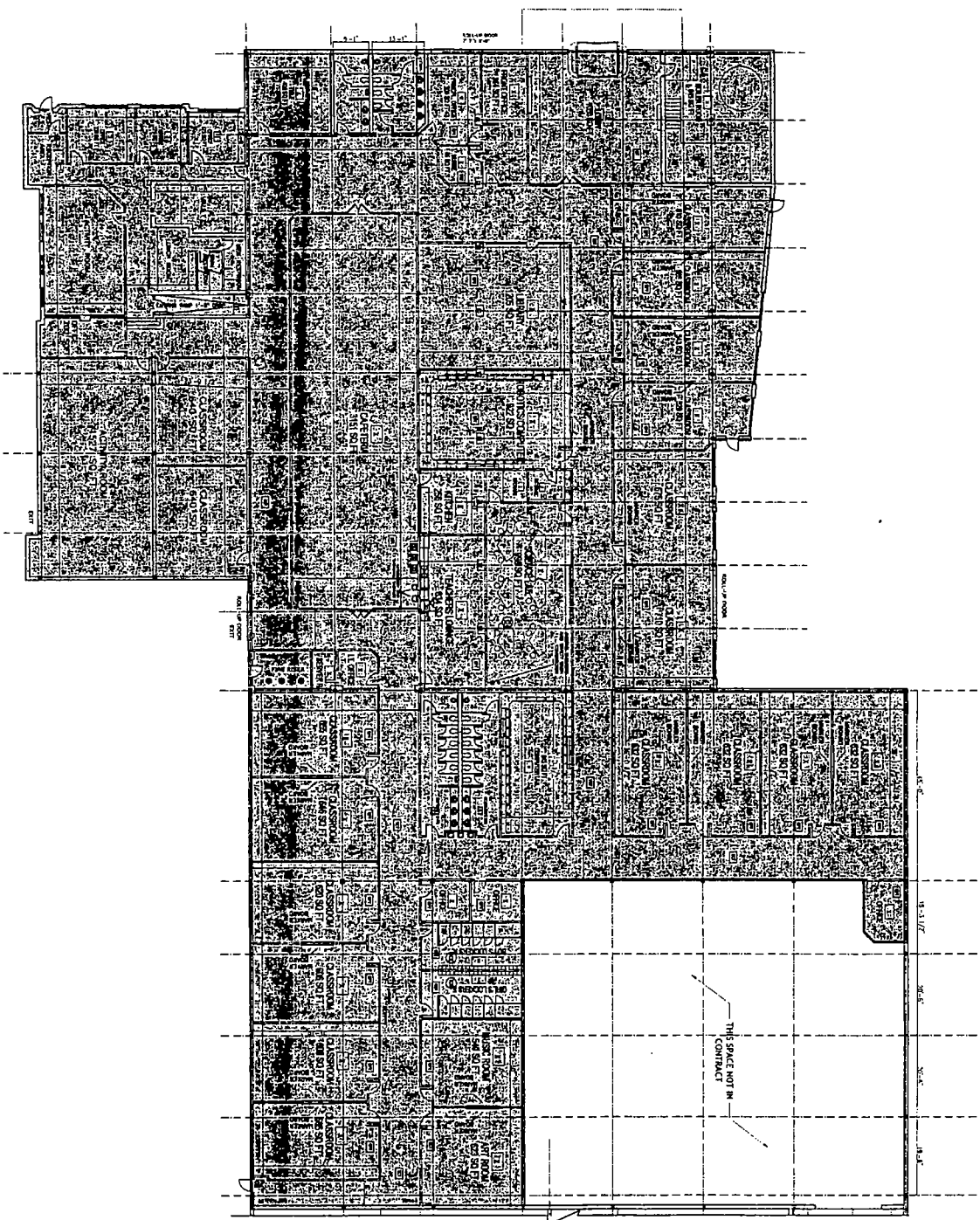

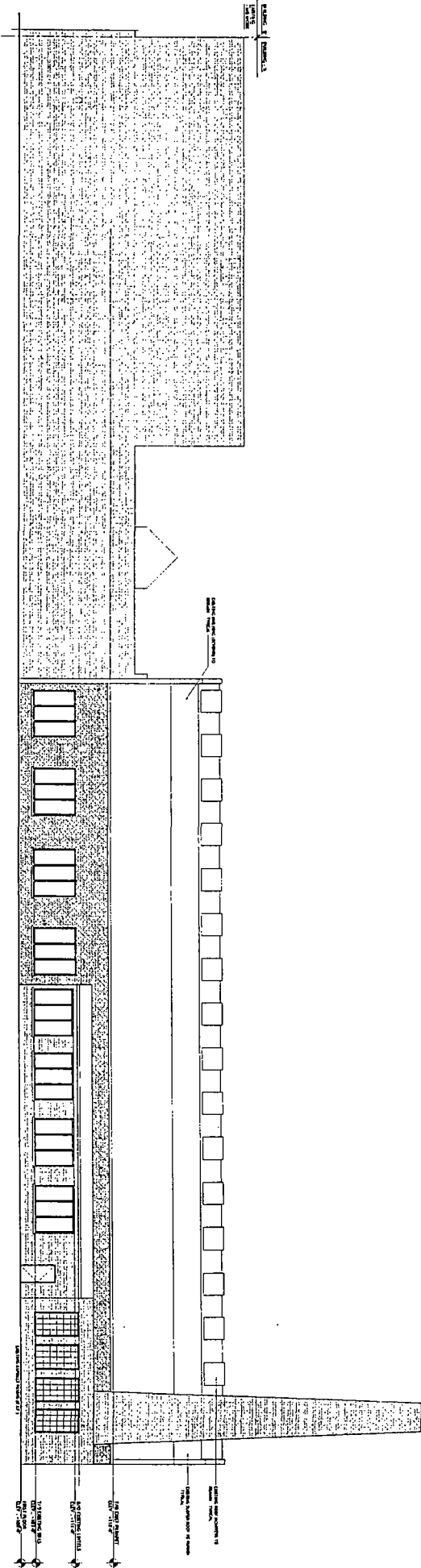


PROPOSED WEST (FRONT) ELEVATION
