ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B2-3 Neighborhood Mixed-Use District symbols and indications as shown on Map No. 11-H in the area bounded by

a line 50 feet south of and parallel to West Leland Avenue; North Damen Avenue; a line 130 feet south of and parallel to West Leland Avenue; a line 41.75 feet west of and parallel to North Damen Avenue; a line 126.67 feet south of and parallel to West Leland Avenue; a line 66.68 feet west of and parallel to North Damen Avenue; a line 130 feet south of and parallel to West Leland Avenue; the alley next west of and parallel to North Damen Avenue,

to those of a C1-3 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A, please be informed that on or about **August 29, 2019**, I, the undersigned, intend to file an application for a change in zoning from a B2-3 Neighborhood Mixed-Use District to a C1-3 Neighborhood Commercial District, on behalf of the Applicant-Owner - 4646 Damen LLC, for the property located at **4646-4650 North Damen Avenue**, **Chicago**, **Illinois**.

The Applicant is seeking a *Zoning Map Amendment* in order to permit the location and establishment of a *veterinary clinic* within the grade-level (1st Floor), of the partially constructed and fully permitted four-story mixed-use building, at the subject site. Per the permits, the new four-story building will have commercial-office space – at grade-level, which will be exclusively occupied by the proposed *Veterinary Clinic*. There will be a total of twenty-four (24) dwelling units – located between the 1st thru 4th Floors. Because the subject property is located within 1,320 linear feet of the entrance to the Damen CTA rail station, the building was originally permitted pursuant to the Transit Oriented Development (TOD) Ordinance. As such, the plan calls for the establishment of off-street surface parking - for eight (8) vehicles, to be located at the rear of the site. Upon completion, the new building will be masonry in construction and measure 48 feet–0 inches in height.
