SECTION 2 The ordinance shall be in force and effect from and after its passage and due publication.



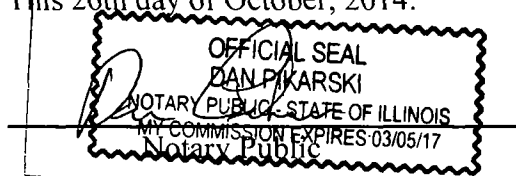


City Ordinance (Municipal Code, Section 17-13-0107) requires that I send you this notice.

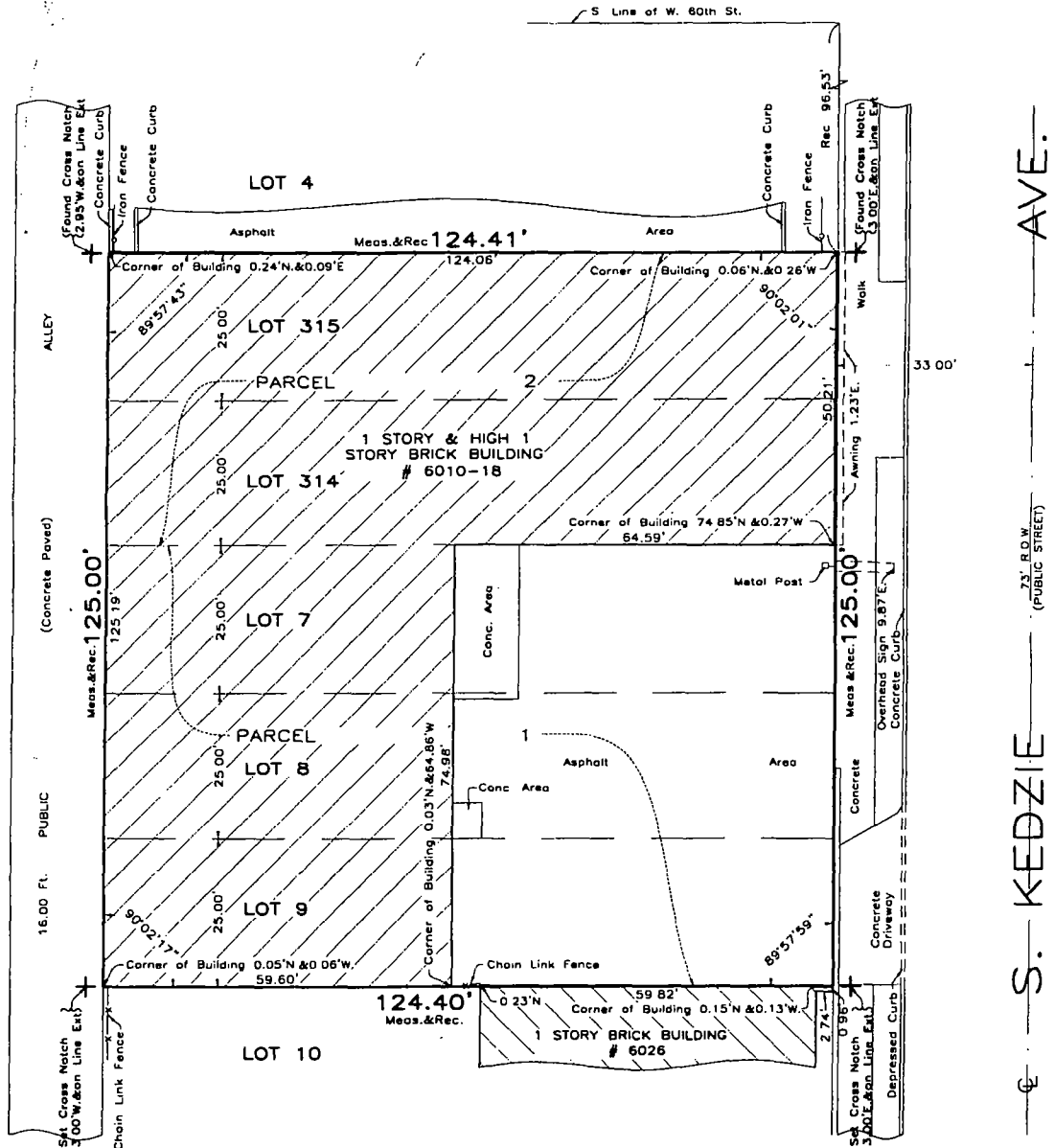
