ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the C1-2 Neighborhood Commercial District symbols and indications as shown on Map 1-G in the area bounded by:

West Lake Street; North Racine Avenue; a line 180 feet south of and parallel to West Lake Street; a line 87.80 feet west of and parallel to North Racine Avenue; a line 181 feet south of and parallel to west Lake Street; a line 162.80 feet west of and parallel to North Racine Avenue

to those of the DX-5 Downtown Mixed-Use District in accordance with the attached narrative and plans.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and publication.

McCaffery Lake Street LLC is the "Applicant" for a Type 1 Zoning Map Amendment for the subject property located at 1201 W. Lake Street from the C1-2 Neighborhood Commercial District to the DX-5 Downtown Mixed-Used District as a Type 1 zoning map amendment.

The subject property consists of 29,350 square feet and is currently occupied by an existing non-conforming commercial building. The Applicant proposes to construct a new 7-story commercial building containing approximately 11,667 square feet of retail and 135,083 square feet of office on floors 2 through 7. 50 parking spaces will be provided. The property is entitled to parking reductions pursuant to the transit-served locations provisions of the Zoning Ordinance, as it is within 1,320 feet from the Morgan CTA entrance.





As required by Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about October 27, 2016, the undersigned, on behalf of McCaffery Lake Street LLC (the "Applicant"), intends to file an application to rezone the property located at 1201-1215 West Lake; 166-182 North Racine Avenue, Chicago, Illinois, (the "Property") from the C1-2 Neighborhood Commercial District to the DX-5 Downtown Mixed-Used District as a Type 1 Zoning Map Amendment. A map of the Property is printed on the reverse side of this letter.

The Property is currently an existing commercial building. The application requests a rezoning of the Property from the C1-2 Neighborhood Commercial District to the DX-5 Downtown Mixed-Used District as a Type 1 Zoning Map Amendment, to allow the construction of a new 7-story commercial building containing approximately 11,677 square feet of retail and 135,083 square feet of office on floors two through seven. Fifty parking spaces will be provided on the ground floor and mezzanine. The property is entitled to parking reductions pursuant to the transit-served locations provisions of the Zoning Ordinance, as it is within 1,320 feet from the Morgan CTA entrance.
