ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B3-2 Community Shopping District symbols and indications as shown on Map No.3-H in the area bounded by

a line 75 feet southeast of and parallel to West Evergreen Avenue; North Milwaukee Avenue; a line 125 feet southeast of and parallel to West Evergreen Avenue; and a line 114 feet southwest of and parallel to North Milwaukee Avenue,

to those of a B3-3 Community Shopping District and a corresponding use District is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

Trust No. 11-5124, Dated March 10, 1999, for the property located at **1420 North Milwaukee Avenue, Chicago, Illinois**.

The Applicant is seeking a *Zoning Map Amendment* in order to permit the location and establishment of four (4) additional dwelling units – for a total of eight (8) dwelling units, on and between the 2nd and 3rd Floors, of the existing three-story mixed-use (commercial-residential) building, at the subject site. The 1st Floor of the existing building will continue to contain two (2) commercial-retail storefronts.
