ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District and C2-2 Motor Vehicle-Related Commercial District symbols as shown on Map No. 10-J

in the area bounded by:

A line 106.04 feet north of and parallel to the south boundary line of the east west public alley next northwest of South Archer Avenue; South Sawyer Avenue; South Sawyer Avenue; South Archer Avenue; South Spaulding Avenue; South Spaulding Avenue; east west public alley next northwest of South Archer Avenue; public alley next east of and parallel to South Spaulding Avenue.

To those of a C2-1, Motor Vehicle-Related Commercial District

SECTION 2. This Ordinance takes effect after its passage and approval.
