SUBDIVISION ORDINANCE

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. The Commissioner of the Chicago Department of Transportation ("Commissioner"), or her designee, is hereby authorized and directed to approve a proposed Riverside Subdivision, being a subdivision of certain lots owned by Riverbend Real Estate Investments LLC ("Developer"), the Riverside Owners Association (representing townhome owners), and various single family home property owners (all three entities/groups collectively, the "Owners"), as reflected on the attached plat, in the block bounded approximately by S. Lock Street, S. Hillock Avenue, the South Branch of the Chicago River (approximately S. Pitney Court) and S. Archer Avenue and legally described in the attached plat (**Exhibit A**, CDOT File: 29-11-19-3900) which, for greater certainty, is hereby made a part of this ordinance.

SECTION 2. The Commissioner is further authorized to accept as new public way, certain street and alley dedications of property heretofore currently held in title by the Owners and legally described in the Plat of Subdivision hereto attached as **Exhibit A**.

SECTION 3 The Owners expressly acknowledge that all water service lines, mains, cisterns, hydrants and appurtenances contained within the area herein subdivided, including in the streets and alleys herein dedicated, shall remain the private property and maintenance responsibility of said Owners, in accordance with the Amended and Restated Covenant recorded with the Office of the Cook County Recorder of Deeds on March 23, 2006, as document 0608231114 ("Covenant"), recorded against the unsubdivided lot known as PIN 17-29-309-036, with the same boundaries as the subject subdivision, said Covenant attached hereto as **EXHIBIT B** and incorporated herein, and the Department of Water Management letter dated June 3, 2019, which is attached hereto as **EXHIBIT C** and incorporated herein.

SECTION 4. The Owners also expressly acknowledge that the sewer lines, catch basins and associated sewer system structures within the area herein subdivided, including within the streets and alleys herein dedicated, shall remain private property and the maintenance responsibility of the Owners in accordance with the Covenant attached hereto as **EXHIBIT B**, and the Department of Water Management letter dated June 3, 2019, attached hereto as **EXHIBIT C**.


SECTION 5. The subdivision herein provided for is made with the acknowledgement of the Commissioner that the Developer has paid the quoted sum sufficient to defray the cost of work to public rights of way herein dedicated, and related appurtenances associated with the Developer's work, in the event that the Developer defaults in its obligation to construct the directed improvements in accordance with the most current version of the Chicago Department of Transportation's Regulations for Opening, Repair and Construction in the Public Way and its appendices, and in accordance with the executed Duty to Build Agreement attached hereto as Exhibit D and incorporated herein. Developer agrees to submit for field inspection and approval of its construction of said improvements, to the CDOT Division of Infrastructure Management, Construction Compliance Unit, Room 905 City Hall, prior to the return of the monies deposited there (minus service fee).

SECTION 6. The subdivision herein provided for is made under the express condition that the Owners, their successors and assigns, shall hold harmless, indemnify and defend the City of Chicago from all claims related to the subdivision.

SECTION 7. The resubdivision herein provided for is also made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Developer shall file or cause to be filed for recordation with the Office of the Recorder of Deeds of Cook County, Illinois, a certified copy of this ordinance, together with the full-sized corresponding plat and survey as approved by the Department of Transportation's Superintendent of Maps and Plats.

SECTION 8. This ordinance shall take effect and be in force from and after its passage and publication. The subdivision shall take effect and be in force from and after the recording of the approved ordinance and associated plat.






**AMENDED AND RESTATED
COVENANT**

Know all men by these presents that the undersigned, Riverside Homes LLC, an Illinois Limited Liability Company, holder as aforesaid of the title to the property legally described on Exhibit A attached here to does hereby covenant and agree for itself, its successors and assigns that the maintenance and repair of the common sewer lines located anywhere on the property from the point of connection to the sewer main in the public street shall be the responsibility of the owners of the thirteen (13) single family homes and

twenty-four (24) townhomes to be constructed as approved by the City of Chicago, is amended from time to time, and shall not be the responsibility of the City of Chicago. The undersigned further states that this covenant shall run with the land and shall be binding upon all subsequent grantees. This covenant is made to induce the City of Chicago to furnish sewer and water service to the above described premises.

Also, the undersigned does hereby covenant and agree for itself, its successors and assigns, that the maintenance and repair of the water service trunk line located anywhere on the property from the point of connection to the water main in the public street shall be the responsibility of the owner of said homes or townhomes, and shall not be the responsibility of the City of Chicago.

The undersigned does hereby further covenant and agree for itself, its successors and assigns, that the buffalo boxes (water service shut-off valves) and water meters for said homes or townhomes shall be accessible at all times to the City of Chicago.

The City of Chicago Water Department will have the right to come on the private property to shut off water for non-payment.



Mr. Vlcek:

This correspondence is in response to a request from Morgan Street Development regarding the proposed subdivision of the Riverside Homes development and is pursuant to a May 22, 2019, meeting with the Department of Water Management (DWM).

The DWM cannot accept ownership of the existing water and sewer facilities within this proposed subdivision since the existing facilities do not meet DWM's standards nor requirements. The subdivision was not initially designed to DWM's standards and constructed without proper DWM inspection since the water and sewer facilities were to be private. The existing water main is not sized appropriately to meet fire flow requirements. The existing sewer system was constructed with separate sanitary and storm mains, along with a bioswale, all as a private system. Additionally, the design drawing for the utilities in the proposed subdivision show violations of water/sewer separation requirements set forth in the Illinois Administrative Code Title 35. The DWM requires that the existing water and sewer facilities remain privately owned as stated within the executed covenant for the subdivision (attached). An easement or Grant of Privilege for private utilities within the proposed public way needs to be added to the proposed subdivision documents.

Should Morgan Street Development request that the DWM take ownership of the water facilities within the subdivision, Morgan Street Development must replace all the water facilities to meet DWM's standards and requirements, including Illinois Administrative Code Title 35 water/sewer separation requirements, at Morgan Street Development's sole cost and expense, and comply with the following:

- The current 8-inch water main within W Grove Street, S Broad Street, and S Pitney Court must be upsized to a 12-inch water main to meet fire flow requirements. All existing pipe, valves, fire hydrants, fittings and other appurtenances must be replaced to current DWM standards.

The proposed water main must be Class 56 ductile iron pipe, polywrapped and backfilled per current DWM standards.

- The existing master meter is to be removed, the account canceled, and all residences within the proposed subdivision must have new water services from the proposed 12-inch water main to a new service control valve and meter vault within the parkway. All existing water service pipe, fittings, shut-off boxes and other appurtenances must be replaced to current DWM standards. The proposed water services must be Type K copper tubing and backfilled per current DWM standards. Any brass parts or fittings must adhere to the "No-Lead Brass" provisions of the City of Chicago Municipal Code.
- Plans must be submitted to the DWM for review and approval of the proposed 12-inch water main prior to construction. All permits for the work must be obtained, including individual water service permits for each residence for which a new water service will be required. All work is to be inspected by the DWM and installed to DWM's standards.
- Morgan Street Development shall be responsible for DWM's actual costs of involvement in the project. The DWM will have construction inspection services during Morgan Street Development contractor's work, water quality services, and make the final water connection in S Lock Street at an approximate cost of \$60,000. Once the new water main is approved for service, the DWM will also make the tap (only) for each water service at an estimated cost of \$1,800 each. Note that the costs listed above are approximate only and the DWM will provide more developed estimates once plans have been submitted to the DWM for review and approval.
- All sewer and water installations must meet separation requirements pursuant to Illinois Administrative Code Title 35 and City of Chicago Municipal Code.

Should Morgan Street Development request that the DWM take ownership of the sewer facilities within the subdivision, Morgan Street Development must meet DWM's standards and requirements, including Illinois Administrative Code Title 35 water/sewer separation requirements, at Morgan Street Development's sole cost and expense, and comply with the following:

- Verify the roof drainage system is independent of any other storm water.
 - The existing private roof drainage system within the area to be dedicated must have a private easement established at the expense of the beneficiary.
- The storm water system that drains the proposed dedicated area must be separate from the existing drainage system required for the site's stormwater management plan. Currently, the surface drainage from the areas to be dedicated flow into the river through private bioswale. All proposed areas to be dedicated must have a separate public storm drainage system that directly drains to the river. The use of the bioswale is not to be used for public ROW drainage. All public storm drainage systems outside the areas to be dedicated must have proper easements or Grant of Privileges established at the expense of the beneficiary.

- Any underground sewer work, including separate public main storm sewers and structures associated with the proposed dedications, must be submitted for review and installed at the expense of the beneficiary. The maintenance of the new separate public storm sewers and structures will be accepted by the DWM only after physical and videotape inspection approved by the DWM.
- All sewer and water installations must meet separation requirements pursuant to Illinois Administrative Code Title 35 and City of Chicago Municipal Code.

For both the proposed water and sewer facilities, any existing above ground structures within the proposed public way (light poles, trees, etc.) may need to be relocated by Morgan Street Development to accommodate DWM's separation requirements from such facilities. Also, Morgan Street Development shall be responsible for relocating any existing underground utilities (power, gas, phone, etc.) that are in conflict with the proposed water and sewer facilities or that do not meet DWM's separation requirements.
