ORDINANCE

BE IT ORDAINED BY THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Community Shopping District and RS-2 Residential Single-Unit District symbols and indicators as shown on Map No. 7-N in the area bounded by

West Belmont Avenue; a line 124.25 feet west of and parallel to North Nottingham Avenue; a line 256.44 feet south of and parallel to West Belmont Avenue; a line 72.26 feet west of and parallel to North Nottingham Avenue; a line 136.28 feet south of and parallel to West Belmont Avenue; North Nottingham Avenue; a line 120.28 feet south of and parallel to West Belmont Avenue; and a line 26.75 feet west of and parallel to North Nottingham Avenue.

to those of a B2-1 Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
