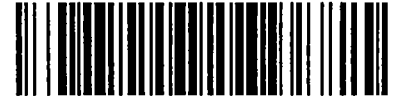

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CLARK-BRIAR P& A, LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Bay Window(s) projecting over the public right-of-way adjacent to its premises known as 3365-69 N Clark St..

Said Bay Window(s) at W. Roscoe Street measure(s):

One (1) at eighteen point seven five (18.75) feet in length, and three point seven five (3.75) feet in width for a total of seventy point three one (70.31) square feet.

Said Bay Window(s) at N. Clark Street measure(s):

One (1) at eighteen point seven five (18.75) feet in length, and five point five (5.5) feet in width for a total of one hundred three point one three (103.13) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development)

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1139971 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

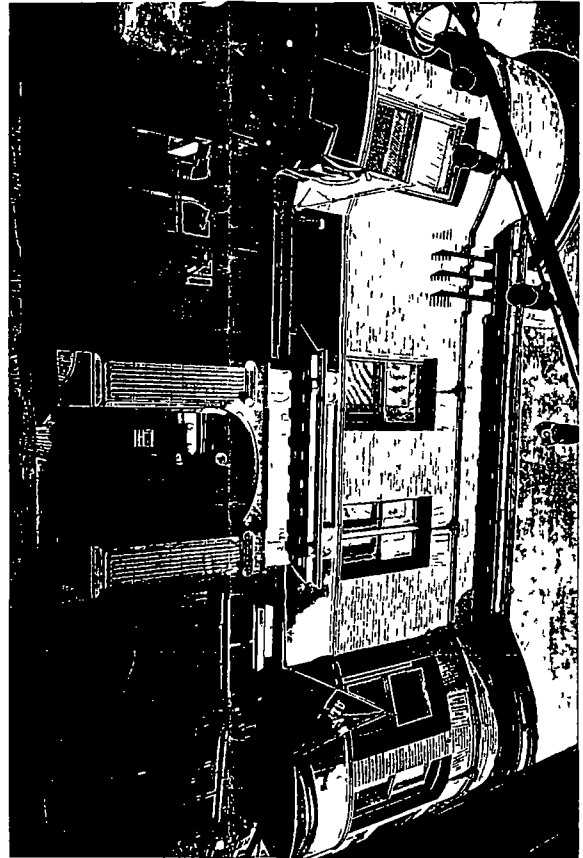
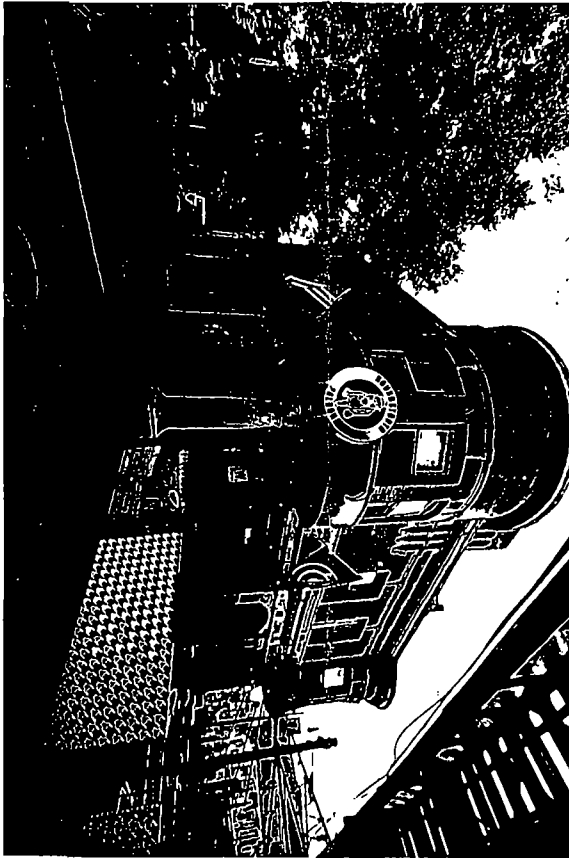
