Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to ALOHA POKE, upon the terms and subject to the conditions of this ordinance to maintain and use one (1) sign(s) projecting over the public right-of-way attached to its premises known as 163 W. North Ave..

Said sign structure(s) measures as follows; along W North Ave:

One (1) at three (3) feet in length, two point four two (2.42) feet in height and eight point three four (8.34) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.


This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1130672 herein granted the sum of one hundred (\$100.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.

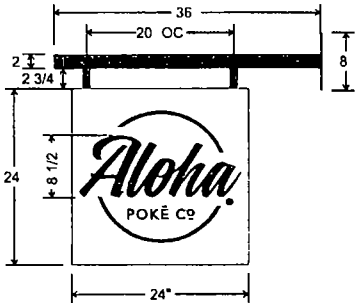
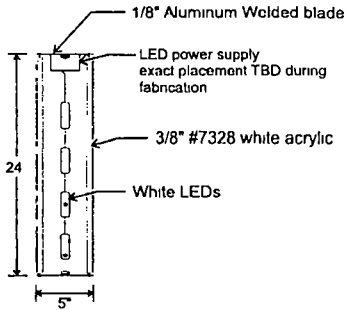
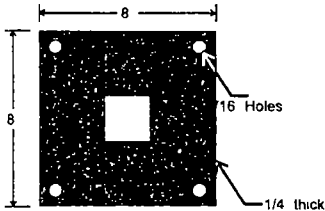

5' deep fabricated 1/8" welded aluminum D/S blade sign internally illuminated white LEDs around perimeter
3/8" #7328 white acrylic with routed shoulder for trimcap-less fabrication face decorated with black vinyl


LED power supply located inside blade exact placement TBD during fabrication

Mounted with square aluminum tubes welded to framing electrical to run through supports welded to cantilever support arm and plate

1/4" thick 8x8 plate bolted to building install in mortar joints as able
All elements painted PMS Black 7 U

Run electrical feed from last junction box on top of awning to the new location
