WEIGHT LIMITATIONS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 72, Section 030 of the Municipal Code of Chicago, the Maximum Weight Permitted to be carried by any truck or commercial vehicle upon the following public ways between the limits indicated except for the purpose of delivering or picking up material or merchandise shall be as follows:

20	West 48th Street from South Ashland Avenue to South Paulina Street; Weight Limitations 5 - Tons -- (15-01879968) [O2015-2014]
20	South Paulina Street from West 47th Street to West 49th Street; Weight Limitations 5 - Tons -- (15-01880104) [O2015-2016]
44	North Racine Street; North Racine Street from North Diversey Avenue to North Belmont Avenue; Weight Limitations - 5 Tons [O2016-7145]
