No changes are proposed to the existing maximum Building Height of 348 feet (measured at the underside of the top habitable floor's ceiling, per the current Zoning Ordinance).



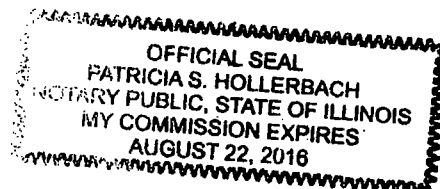

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about November 7, 2012, the undersigned attorney filed an application for a change in zoning from the RM6.5 Residential Multi-Unit District to B3-5 Community Shopping District and from B3-5 Community Shopping District to a Residential-Business Planned Development. This application was filed on behalf of RP Hyde Park, LLC (“Applicant”) for the property located at 5020-5050 South Lake Shore Drive (“Regents Park,” or the “Property”). In accordance with the requirements of Section 16-4-100(c) (formerly 194B-6.1(c)) of the Lake Michigan and Chicago Lakefront Protection Ordinance (the “LPO”), please be informed that on or about November 7, 2012, the undersigned attorney also filed an application pursuant to the LPO with the Chicago Plan Commission on behalf of the Applicant for this same redevelopment proposal.

Also in accordance with City requirements, please be informed that the applicant for both applications is RP Hyde Park, LLC; Applicant is the owner of the Property; Applicant is located at the following address: c/o Antheus Capital, 32 North Dean Street, 2nd Floor, Englewood, New Jersey 07631; and the attorney for Applicant and contact person for both applications is Danielle Meltzer Cassel, Vedder Price P.C., 222 N. LaSalle Street, Suite 2600, Chicago, Illinois 60601, (312) 609-7962, dcassel@vedderprice.com.

Please note that Applicant is not seeking to rezone or purchase your property. Applicant is required by law to send this notice because you are listed in the records of Cook County as the taxpayer or owner of a property that is within 250 feet, more or less, of the Property.

BRIEF PROPERTY DESCRIPTION

Regents Park was developed by its original owners in the early 1970s as a high-rise, multi-tower apartment building, with 1038 dwelling units. The Property was modified and expanded by other owners at various times during the subsequent decades, including the addition of various non-residential uses, including a member-based fitness center and pool area that were operated for the general public (as well as residents), a coffee shop, dry cleaner, market and a casual restaurant within the pool area. For the most part, the Property’s original construction and subsequent modifications occurred when the Property had zoning designations that no longer exist under today’s Zoning Ordinance. The Property currently has approximately 1.5 million square feet of gross building area (including its basement and garage space) and approximately 1.25 million square feet of building area for the purpose of measuring “Floor Area Ratio” under the Zoning Ordinance. The Property includes an interior garage with approximately 627 standard parking spaces and 40 tandem spaces (none of which are handicapped accessible, and many of which have dimensions or drive aisles that disqualify them as legal parking spaces under the current Zoning Ordinance).

Applicant acquired Regents Park approximately one year ago. Four current conditions at the Property that arose under prior ownership are particularly important for the proposed renovations (described below). First, the Property lacks handicapped parking spaces and accessible pedestrian entrances. Second, while the North Tower was originally constructed with 16 apartments per residential floor, prior owners modified this configuration on the third floor (in some cases to introduce non-residential tenants) and thirty-fifth floor (to combine units). Third, Applicant perceives that the garage requires significant capital repairs and that the property’s exterior at street level could benefit from improvements to entrances, façade design, and landscaping. Finally, the Property’s current zoning designation effectively prevents many of the renovations RP Hyde Park believes would be beneficial for residents and neighborhood, including its proposed renovations for the East End entrance and renovations that would allow the existing fitness center

and pool area to be reconfigured and then re-opened for use by both residents and by other community members.

BRIEF PROJECT DESCRIPTION

Applicant's two applications are being submitted in connection with a proposed, privately-funded renovation for portions of Regents Park. The following is a brief overview of the proposed renovations and what the proposed Planned Development, if approved, would allow.

Residential Housing. Regents would be permitted to continue having 1038 residential units as permitted by its original zoning, including the original 16 units per floor in the North Tower.

Bicycle and Car Accommodations: Garage interiors and entrances, including the surface area entrance near the Southeast corner of the South Tower, would be renovated to create a dedicated entrance for cyclists, create handicapped parking spaces, improve drive aisle and parking space maneuverability, improve lighting, and provide other safety enhancements designed to reduce potential conflicts between drivers, cyclists and pedestrians. Following the renovations, the garage would provide approximately 14 handicapped-accessible parking spaces, 604 standard spaces, and 51 tandem spaces.

Non-Residential Uses: Although the proposed Planned Development will technically have an underlying Business District, the Planned Development itself will have much more narrow restrictions regarding the location and type of allowable non-residential uses. For example, the Planned Development will permit the Building's upper floors (third floor and higher) to have only tenant amenities (such as rooms for tenant meetings and events), residential dwelling units, and a potential use for 20 of those residential units as occasional temporary, furnished lodging. For the balance of the Building (essentially its ground level and garage), the proposed terms of the Planned Development will allow a continuation of existing non-residential uses (dry cleaning, retail sales of packaged food, beverages and general merchandise, one or more restaurants, tenant business center, salon, and car washing within the garage), the reestablishment of a fitness center and pool that is open to both residents and non-residents, and the creation of a new sit-down General Restaurant with accessory liquor sales and outdoor dining. While there are no current plans to implement such uses, the proposed Planned Development also would permit artist work space, a day care, certain rooftop wireless communication facilities, and other miscellaneous and accessory uses that have the potential to be beneficial in the future.

Please understand that the proposed Planned Development ordinance and renovations will have features we cannot fully describe in this letter and that the project will continue to evolve with input from City Departments, City officials and the community. The area delineated herein as Planned Development Number _____ (“Planned Development”) consists of approximately 136,652 square feet of property which is depicted on the attached Planned Development Boundary and Property Line Map (“Property”) and is owned or controlled by the Applicant, RP Hyde Park LLC. The Property is currently improved with an existing, 37-story, multi-tower, mixed-use building (the “Building”) that was originally constructed in the 1970s with 1038 dwelling units and was then modified, on multiple occasions, prior to the effective date of this Planned Development. Modifications to the Building and Property included, among, other things, modifications to reduce on-site parking and loading; the establishment of various commercial businesses on the first and third floors of the Building; the establishment of a fitness and pool center with an area in excess of fourteen thousand square feet; increases of building foot print and floor area ratio; modifications to the configuration and use of original dwelling units; and the creation of an approximately 57,000 square foot rooftop garden (the “Bergen Garden”). All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

4. This Plan of Development consists of 15 Statements: a Bulk Regulations Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; Site Plan; Landscape Plan; a Green Roof Plan; Sub-Basement Plan; Basement Plan; Level 1 Plan; Level 2 Plan; Level 3 Plan; Level 4 - 35 Typical Plan; Level 36 Plan; Level 37 Plan; and Building Elevations (West Elevation; South Elevation; East Elevation; and North Elevation) and Chicago Builds Green form prepared by Studio Gang Architects and dated (date of Plan Commission presentation), submitted herein. Full-sized copies of the Site Plan, Landscape Plan and Building Elevations are on file with the Department of Housing and Economic Development. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.
5. The following uses are permitted uses in the area delineated herein as the Planned Development, and no additional special use approval shall be required for any of the following: (i) Artist Live/Work Space and Dwelling Units located on Levels 3 or higher; (ii) Lodging, including but not limited to Vacation Rental and Hotel uses, within a maximum of twenty (20) such Dwelling Units; (iii) Day Care; (iv) Limited and General Restaurants, including rooftop and grade-level Outdoor Patios, and also including Limited Manufacturing, Production and Industrial Services (catering & shared kitchen only); (v) Automated Teller Machine Facility located on Level 3 or lower; (vi) Food and Beverage Retail Sales, including Liquor Sales as an accessory use, but excluding Liquor Stores, and only if located on Level 3 or lower; (vii) Personal Service, excluding Massage Establishments, and only if located on Level 3 or lower; (viii) Consumer Repair or Laundry Service, including Dry Cleaning drop-off or pick-up but no on-premise plant; (ix) General Retail Sales located on Level 3 or lower; (x) Indoor and Outdoor Participant Sports and Recreation; (xi) Accessory and Non-Accessory Parking, including Car-Sharing Services located on Level 2 or lower; (xii) Car Wash or Cleaning Service, but only within garage areas on Level 2 or lower; (xiii) Co-

located Wireless Communication Facilities; (xiv) Resident business center, lounge, meeting and event uses, including but not limited to Private Events, as such term is defined in Section 4-75-010 of the Chicago Municipal Code, provided, however, such uses may only be located within Level 1, the Bergen Garden, North Tower Level 35, and South Tower, Level 36; (xv) accessory uses to any of the foregoing; (xvi) such other RM 6.5 or B3 uses authorized by the Zoning Administrator pursuant to Statement 12. No one or more provisions of this Statement 5 shall prevent or limit the continuation of uses within the Property existing as of the effective date of this Planned Development that previously received all required approvals

6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Housing and Economic Development. Off-Premise signs are prohibited within the boundary of the Planned Development. No one or more provisions of this Statement 6 shall prevent or limit Continuation (as such term is used in Section 17-15-0503 of the Zoning Ordinance), Alteration (as such term is used in Section 17-15-0504 of the Zoning Ordinance), routine maintenance and or repair of signs within the Property existing as of the effective date of this Planned Development that previously received all required approvals, including, without limitation, the existing free-standing signs noted on the Plans
7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration. Except as required by the Federal Aviation Administration, no one or more provisions of this Planned Development shall prevent the Property from continuing to have the heights shown in the Elevations.
8. The maximum permitted Floor Area Ratio ("FAR") for the Property shall be in accordance with the attached Bulk Regulations Table, subject to the provisions of this Statement 8. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance and the Net Site Area set forth in the Bulk Regulations Table shall apply. Notwithstanding the preceding provisions of this Statement 8, the Property currently has, and shall be permitted to continue having, an aggregate, existing floor area (as measured for the purposes of determining floor area ratio in accordance with 17-17-0305-A and 17-17-0305-B) of 1,230,000 square feet (the "Maximum Net Floor Area") and an aggregate sum of gross horizontal area of all floors, measured from the exterior faces of the exterior walls, of 1,480,000 square feet (the "Maximum Gross Floor Area"), which Maximum Net Floor Area and Maximum Gross Floor Area each represent existing legal non-conformities under the Zoning Ordinance. No interior or exterior modifications, repairs or replacements of the Building shall result in the Property's aggregate Floor Area (as measured for the purposes of determining floor area ratio in accordance with 17-17-0305-A and 17-17-0305-B) exceeding the Maximum Floor Area nor result in the gross horizontal area of all floors in all of the Property's buildings measured from the exterior faces of the exterior walls or from the center line of walls separating two buildings, being in excess of the Maximum Gross Floor Area. Without limiting the generality of the foregoing, the Property shall be permitted to have the floor area adjustments shown in the Basement Plan, Level 1 Plan and Level 2 Plan.

Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Housing and Economic Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval. The Part II fee shall be assessed only against: (i) floor area, as measured for Floor Area Ratio purposes under the Zoning Ordinance, that is added to the Building (without any offset for the corresponding floor area to be removed from the Building); and (ii) floor area of any new buildings to be constructed within the boundaries of the Property.
10. Notwithstanding the Bulk Table providing that the Planned Development shall have a minimum of 618 off-street parking spaces, nothing in this Planned Development, nor any Part II Review, shall require the off-street parking spaces within the Property to comply with any minimum space dimension, handicapped-accessibility, vertical clearance, drive aisle, or other similar requirements, as the Property, as of the effective date of this Planned Development, is improved with a multi-level garage that is deficient in all of these respects. As stated in the Open Space Impact Fee Ordinance Section 16-18-080 of the Municipal Code of Chicago, in the case of larger developments that are processed as Planned Developments, developers are encouraged to provide open space and recreational facilities on-site to serve new residents instead of paying open space impact fees. As the Property is fully-improved as of the effective date of the Planned Development, the Property shall be in full compliance with this Statement 14, the City of Chicago Sustainable Development Policy, the Open Space Impact Fee Ordinance, and successor policies to the foregoing, so long as the Property: (i) continues to have an outdoor rooftop garden with square footage equivalent to that shown on the Level 3 Plan; and (ii) does not have an impervious surface ratio in conflict with the Chicago Builds Green Form incorporated as part of this Planned Development.

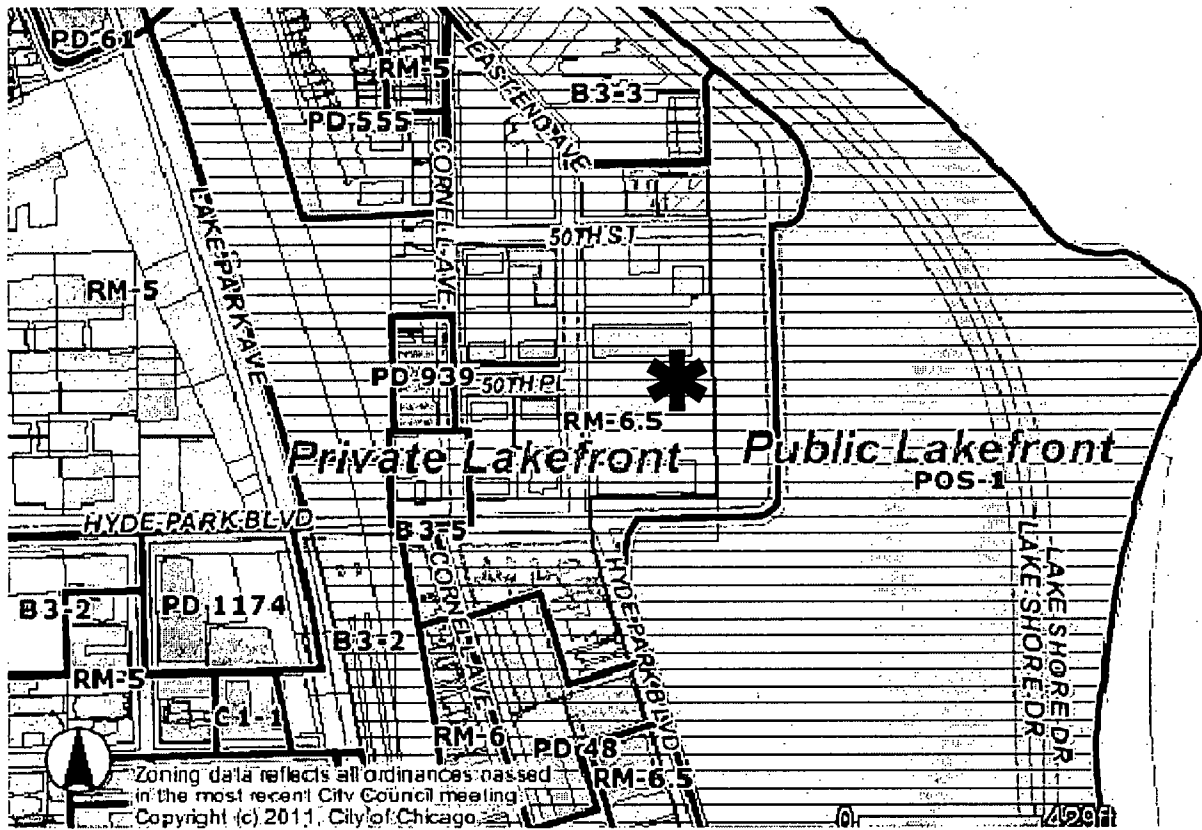

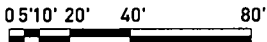
FLOOR PLAN TYPICAL

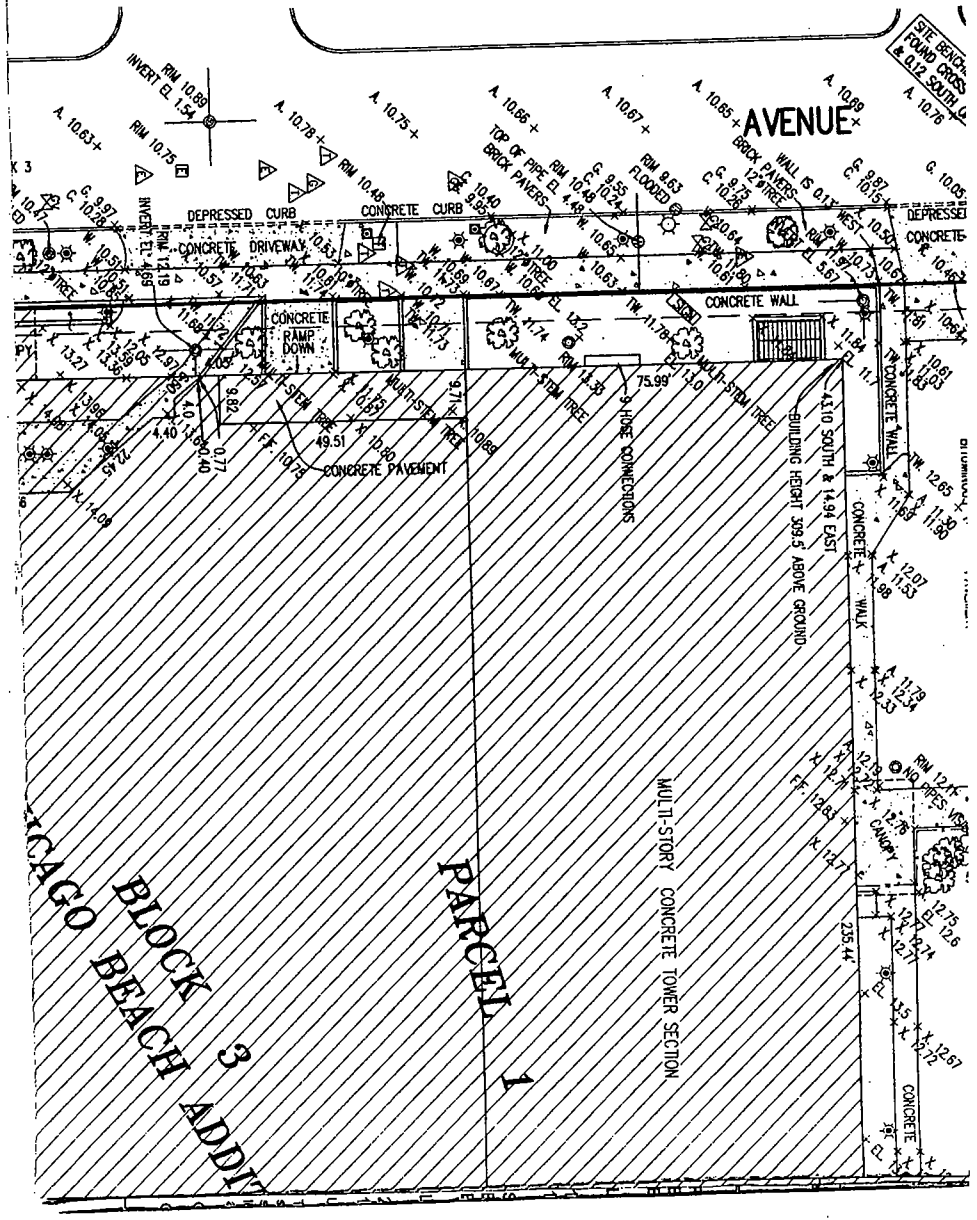
