ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District, as shown on Map 7-I in the area bounded by:

West Diversey Avenue; a line 100 feet East of and parallel to North Campbell Avenue; the alley next North of and parallel to North Diversey Avenue; and a line 125 feet East of and parallel to North Campbell Avenue.

To those of **B2-3 Neighborhood Mixed-Use District.**

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The building height shall be 47 feet 2 inches high, as defined by Code.

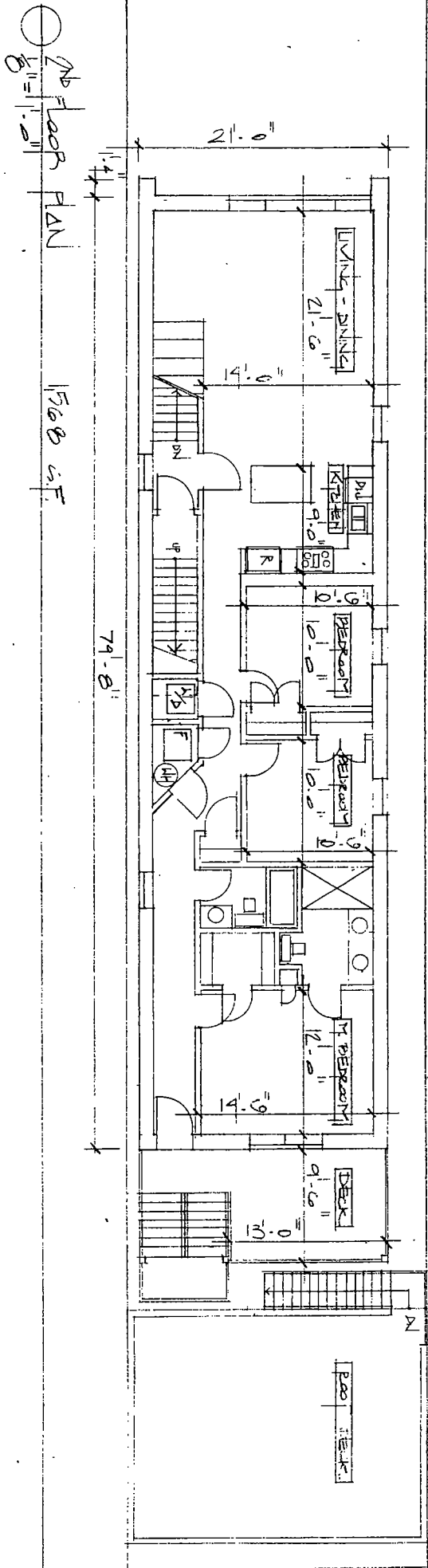
