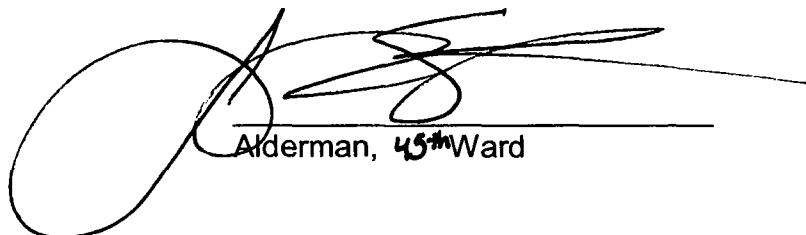

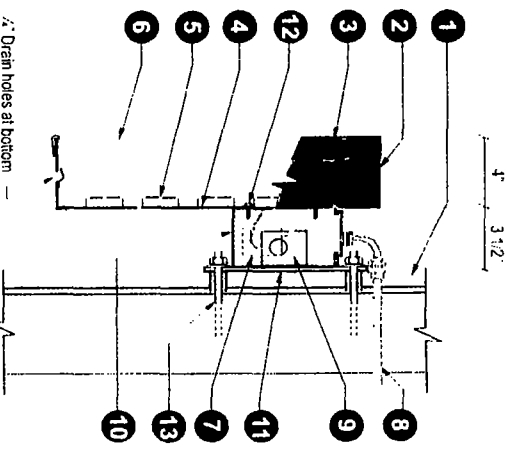


**General Notes:**

- This sign is to be installed in accordance with the requirements of Article 600 of the National Electrical Code.
- 1) Grounded and bonded per NEC 600.7/NEC 250
  - 2) Existing branch circuit in compliance with NEC 600.5 not to exceed 20 amps
  - 3) Sign is to be UL listed per NEC 600.3
  - 4) UL disconnect switch per NEC 600.6 - "Required per sign component before leaving manufacture"
- \*For multiple signs a disconnected is permitted but not required for each section

5. **LEDs** - Letters- Sloan Valve Line Plus Long Red LED modules  
Starts- Sloan Valve Line Plus Short White LEDs
6. **Faces** - Letters- 3/16" 2447 Red LD acrylic  
Starts- 3/16" 2447 White LD acrylic w/ Vinyl 3M#3630-125 Golden Yellow vinyl with 3M#7125-22 Matte Black vinyl outline
7. Waterproof disconnect switch per NEC 600.6
8. Primary electrical feed
9. Transformers
10. 0.080" Raceway (5 1/2" tall x 3 1/2" deep fabricated aluminum). Painted to match facade.
11. 9 x 2 x 0.1875" Aluminum mounting tabs welded to raceway  
- Maximum 6" from each end and every 48" o.c.
12. #12 x 1" TEC screws with 11/4" fender washers
13. Mounting hardware to suit
