LOADING ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:

WARD	LOADING ZONES / STANDING ZONES:
14	4607 South St. Louis Avenue; 4607 South St. Louis Avenue (east side) from a point 30 feet south of South Archer Avenue to a point 35 feet south thereof; No Parking Loading Zone, 8:00am to 8:00pm, All Days (Public Benefit) [O2017-6312]
27	311 North Morgan Street; 311 North Morgan Street (east side) from a point 186 feet north of West Fulton Market to a point 80 feet north thereof; No Parking Loading Zone, All Times, All Days -- (17-046639385) [O2017-4264]
30	North Lowell Avenue; North Lowell Avenue (west side) from a point 20 feet south of West Addison Street to a point 30 feet south thereof; 15 Minute Loading Zone, Use Flashing Lights, 6:00am to 6:00pm, Monday through Friday [O2017-6976]
40	North Campbell Avenue; North Campbell Avenue (east side) from a point 20 feet south of West Granville Avenue to a point 20 feet south thereof; 30 Minutes Standing Zone, Use Flashing Lights, Tow Zone after 30 Minutes, 7:00pm to 9:00pm, Wednesday and Saturday and 9:30am to 3:00pm, Sundays -- (17-04713508) [O2017-4169]
