## **ORDINANCE**

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No.11-H in the area bounded by

the alley next north of and parallel to West Irving Park Road;  
a line 222.20 feet east of and parallel to North Damen Avenue;  
West Irving Park Road; and a line 197.20 feet east of and parallel  
to North Damen Avenue,

to those of a C1-2 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.
