**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 10-I in the area bounded by:**

**West 40th Street; a line 50.80 feet East of and parallel to South Sacramento Avenue; a public alley next South of and parallel to West 40th Street; South Sacramento Avenue.**

**To those of a B1-1, Neighborhood Shopping District**

**SECTION 2. This Ordinance takes effect after its passage and approval.**
