BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/Business Park District symbols and

indications as shown on Map No. 5-G in an area bound by:

A line 23.70 feet Northwest of and parallel to North Kenmore Avenue; North Maud Avenue; North

Kenmore Avenue; and the alley next southwest of and parallel to North Maud Avenue.

To those of a RM – 4.5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.
