The perpendicular public alley to South St. Lawrence Avenue that is next north of and parallel to East 43rd Street; a line 267 feet west of and parallel to South St. Lawrence Avenue and perpendicular to East 43rd Street; East 43rd Street; a line 292 feet west of and parallel to South St. Lawrence Avenue and perpendicular to East 43rd Street,

to those of a B3-1 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.
