BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the B3-3 Community Shopping District symbols and indications as shown on Map No. 5-F in the area bound by:

A line 230.55 feet North of and parallel to West Menomonee Street (as measured along the east boundary line of the public alley next west of and parallel to North Wells Street); North Wells Street; a line 150.13 feet north of and parallel to West Menomonee Street(as measured along the east boundary line of the public alley next west of and parallel to North Wells Street); the public alley next west of and parallel to North Wells Street.

to those of a B1-3 Neighborhood Shopping District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A of the Chicago Zoning Ordinance please be advised that on or about July 23, 2014 I, the undersigned, filed an application for a change in zoning, for the properties located at 1816-1820 North Wells Street from B3-3 Community Shopping District to B1-3 Neighborhood Shopping District.

The applicant is A New Leaf, Inc. with an address at 1645 North Wells, Chicago, IL 60614.

The owner of 1816-1818 North Wells is Marion Parry, as beneficiary of Chicago Title Land Trust, as Successor Trustee under Trust Agreement dated 12/4/86 and known as Trust Number 1463. The owner of 1820 North Wells is Marion Parry, as beneficiary of Chicago Title Land Trust, as Successor Trustee under Trust Agreement dated 7/26/95 and known as Trust Number 1989. Ms. Parry's address is c/o A New Leaf, 1645 North Wells, Chicago, IL 60614.

The purpose of the rezoning is to return the property to its original zoning district of B1-3 in accordance with the terms and conditions of the Declaration of Restrictive Covenant between the applicant and Old Town Triangle Association. The applicant had previously rezoned the property to its current B3-3 designation in order to obtain business licenses to operate the property as a banquet facility with an outdoor patio as well as a photography studio. At the time, the applicant agreed to downzone the property back to the original B1-3 classification once the appropriate business licenses were obtained. No changes to the existing buildings or uses are being made




