ORDINANCE FEDORA LOUNGE Acct. No. 213079 - 1 Permit No. 1096299

Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to FEDORA LOUNGE upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 712 N. Clark St.. Said sidewalk cafe area #1 shall be eighteen point five (18.5) feet in length and eight point five (8.5) feet in width for a total of one hundred fifty-seven point two five (157.25) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along N. Clark Street. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Sunday thru Saturday 11:00 a.m. to 11:00 p.m. Compensation: \$600.00 SEATING CAPACITY: 24

Sidewalk Cafe Permit and approved plan must be posted at all times.

\*Sidewalk Cafes shall not operate earlier than 8:00 AM, nor later than 11:00 PM.

This grant of privilege #1096299 for a sidewalk cafe shall be subject to the provisions of Section 10-28-900 though 10-28-995 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.


