BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 6-J in the area bounded by

WEST CERMAK ROAD; A LINE 41.00 FEET WEST OF AND PARALLEL TO SOUTH SPAULDING AVENUE; A 16 FEET PUBLIC ALLEY NEXT SOUTH OF AND PARALLEL TO WEST CERMAK ROAD; A LINE 66.00 FEET WEST OF AND PARALLEL TO SOUTH SPAULDING AVENUE

to those of a RT4 Residential District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
