A line 273.25 feet north of West 38th Street;
the alley next east of and parallel to South Parnell Avenue;
a line 248.25 feet north of West 38th Street; and
South Parnell Avenue;

to those of RT4 Residential Two-Flat, Townhouse and Multi-Unit District, which is hereby established in the area above described.

SECTION 2: This ordinance shall take effect upon its passage and due publication.



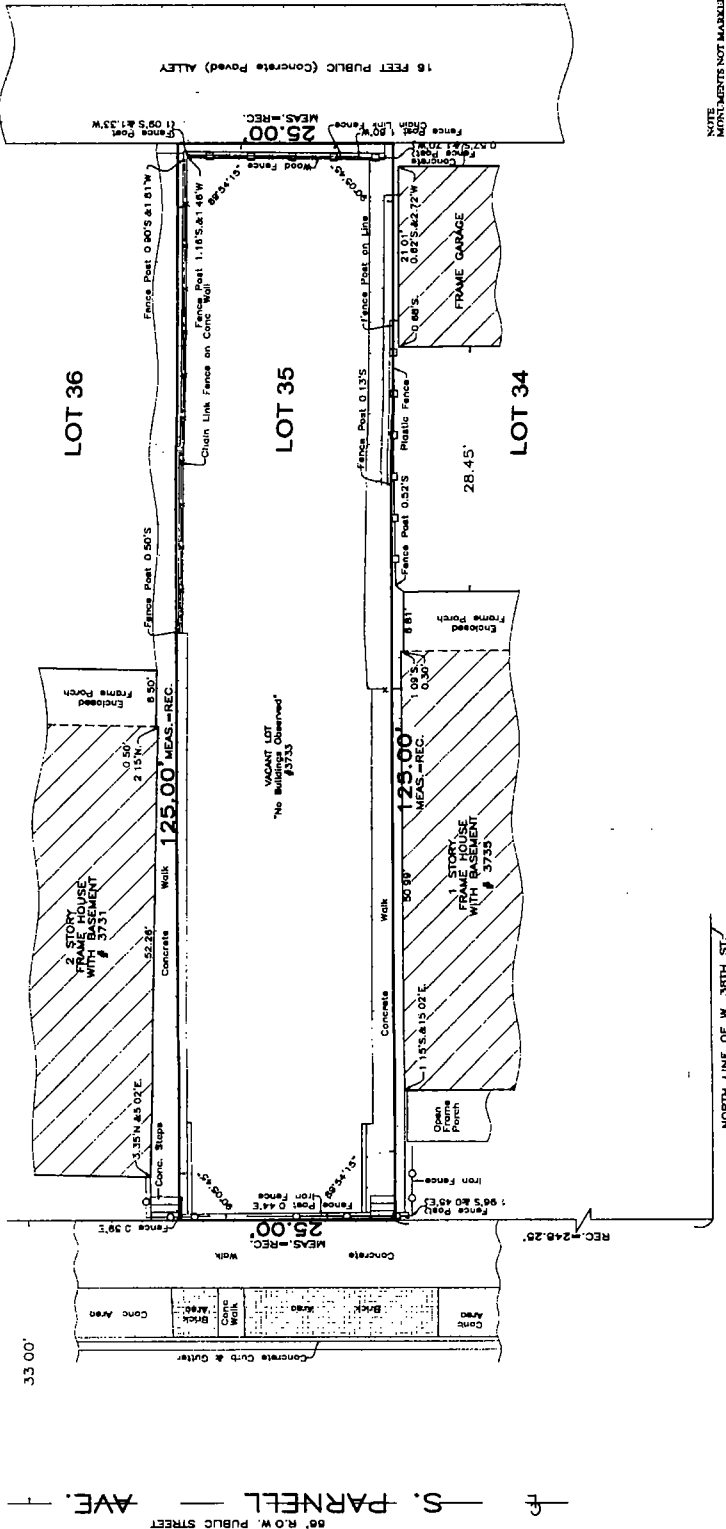

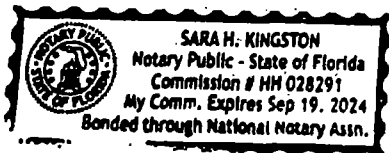
