<u>ORDINANCE</u>

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the C1-1 Neighborhood Commercial District symbols and indications as shown on Map No 9-K in the area bounded by

West Cornelia Avenue; the alley next east of and parallel to North Keeler Avenue; a line from a point 155 feet south of West Cornelia Avenue and the west right-of-way line of the alley next east of and parallel to North Keller Avenue; to a point 28 feet east of North Keeler Avenue and 110 feet south of West Cornelia Avenue; and a line 28 feet east of and parallel to North Keeler Avenue,

to those of a RS3 Residential Single-Unit (Detached House) District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.













2ND. FLOOR PLAN
