
3409 will remain an unchanged, two residential unit building. 3407 will be improved with a single family home that will be constructed consistent to the standards of the proposed RT 3.5 District.

I am writing to notify you that on behalf of my client, John Zabinski, I will file on or about July 18, 2011, an application for a change of zoning designation from a RS-3 Residential Single-Unit (Detached House) District to a RT 3.5 Residential Two Flat, Townhouse and Multi-Unit District under the Ordinance of the City of Chicago for the property located at 3407 -09 North Albany Avenue, Chicago, Illinois, and further described as follows:

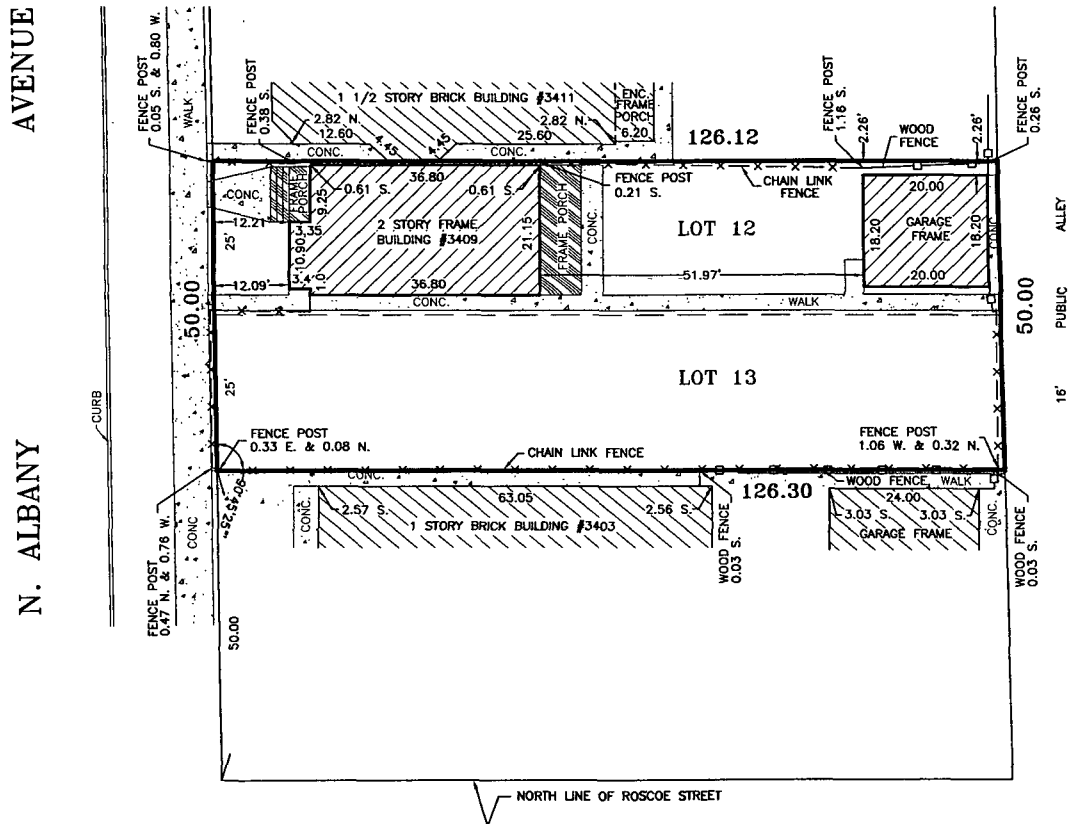
