Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to TARASCAS INTERNATIONAL upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 2585 N. Clark St.. Said sidewalk cafe area #1 shall be eighty-seven point five (87.5) feet in length and seven point three three (7.33) feet in width for a total of six hundred forty-one point three eight (641.38) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along W. WRIGHTWOOD AVE. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:
