RESOLUTION

CLASS 6(B) REAL ESTATE TAX INCENTIVE FOR THE BENEFIT OF PANCAL PULASKI LLC, A DELAWARE LIMITED LIABILITY COMPANY, AND REAL ESTATE LOCATED GENERALLY AT 3348 SOUTH PULASKI ROAD IN CHICAGO, ILLINOIS PURSUANT TO COOK COUNTY, ILLINOIS REAL PROPERTY ASSESSMENT CLASSIFICATION ORDINANCE

WHEREAS, the Cook County Board of Commissioners has enacted the Cook County Real Property Assessment Classification Ordinance, as amended from time to time (the "Ordinance"), which provides for, among other things, real estate tax incentives to property owners who build, rehabilitate, enhance and occupy property which is located within Cook County and which is used primarily for industrial purposes; and

WHEREAS, the City of Chicago (the "City"), consistent with the Ordinance, wishes to induce industry to locate and expand in the City by supporting financial incentives in the form of property tax relief; and

WHEREAS, PanCal Pulaski LLC, a Delaware limited liability company (the "Applicant"), owns certain real estate located generally at 3348 South Pulaski Road, Chicago, Illinois 60623, as further described on Exhibit A hereto (the "Subject Property"); and

WHEREAS, the Applicant intends to construct an approximately 316,680 square foot industrial facility located on the Subject Property; and

WHEREAS, the Applicant has filed with the Office of the Assessor of Cook County (the "Assessor") an eligibility application for a Class 6(b) tax incentive under the Ordinance; and

WHEREAS, the Subject Property is located within the Little Village Industrial Corridor Redevelopment Project Area (created pursuant to the Illinois Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4-1 et. seq., as amended, and pursuant to an ordinance enacted by the City Council of the City), and the purpose of the Redevelopment Project Areas is also to provide certain incentives in order to stimulate economic activity and to revitalize depressed areas; and

WHEREAS, it is the responsibility of the Assessor to determine that an application for a Class 6(b) classification or renewal of a Class 6(b) classification is eligible pursuant to the Ordinance; and

WHEREAS, the Ordinance requires that, in connection with the filing of a Class 6(b) eligibility application with the Assessor, the applicant must obtain from the municipality in which such real estate that is proposed for Class 6(b) designation is located a resolution expressly stating that the municipality has determined that the incentive provided by Class 6(b) is necessary for development to occur on such real estate and that the municipality supports and consents to the Class 6(b) classification by the Assessor; and

WHEREAS, the intended use of the Subject Property will provide significant present and future employment; and

WHEREAS, notwithstanding the Class 6(b) status of the Subject Property, the redevelopment and utilization thereof will generate significant new revenues to the City in the form of additional real estate taxes and other tax revenues; now therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: That the City determines that the incentive provided by Class 6(b) is necessary for the development to occur on the Subject Property.

SECTION 2: That the City supports and consents to the Class 6(b) classification by the Assessor with respect to the Subject Property.

SECTION 3: That the Clerk of the City of Chicago is authorized to and shall send a certified copy of this resolution to the Office of the Cook County Assessor, Room 312, County Building, Chicago, Illinois 60602 and a certified copy of this resolution may be included with the Class 6(b) eligibility application filed with the Assessor by the Applicant, as applicant, in accordance with the Ordinance.

SECTION 4: That this resolution shall be effective immediately upon its passage and approval.

EXHIBIT A

Legal Description of Subject Property:

Excepting from the Southeast Quarter of the Northeast Quarter of said Section 34 the South 600 feet thereof.

Also excepting from said Southeast Quarter of the Northeast Quarter that part thereof described as follows:

Commencing at a point in the West line of said Southeast Quarter of the Northeast Quarter of Section 34, 150 feet South of the Northwest comer of said Southeast Quarter of the Northeast Quarter of Section 34, thence East along a straight line, parallel to the North line of said Southeast Quarter of the Northeast Quarter of Section 34, being the South line of the Right of Way of Chicago and Illinois Western Railroad, a distance of 201.43 feet; thence continuing Southeasterly along the Southerly Right of Way line of said Chicago and Illinois Western Railroad, being a curved line, convex Northerly, tangent to the last described line and having a radius of 1503.14 feet, a distance of 317.74 feet; thence continuing Southeasterly Right of Way of the Chicago and Illinois Western Railroad, being a straight line tangent to the last described curved line, a distance of 64.54 feet to an intersection with a line drawn parallel to and 197 feet South of said North line of said Southeast Quarter of the Northeast Quarter of the Southeast Quarter of the Southeast Quarter of the South along said last described parallel line, a distance of 579.88 feet to said West line of the Southeast Quarter of the Northeast Quarter of said Section 34; thence North along said last described line, a distance of 47 feet to the point of beginning in Cook County, Illinois.
